PETITION FOR ORDER APPROVING
FEES AND COSTS INCURRED BY THE
RECEIVER, SIMON CONSULTING, LLC,
AND GUTTILLA MURPHY ANDERSON,
P.C. FROM JUNE 1, 2018 THROUGH
JUNE 30, 2018

20 Peter S. Davis, as the court appointed Receiver, respectfully petitions the Court as
21 follows:

1. On August 18, 2016, this Court entered its *Order Appointing Receiver*, which
appointed Peter S. Davis as Receiver of DenSco Investment Corporation (“Receivership
Order”).

1 2. Pursuant to *Order Re: Petition No. 1*, the Court approved the Receiver's
2 compensation at the rate of \$250.00 per hour together with all reasonable costs and expenses
3 incurred relating to these services as Receiver. These services are billed by and paid to the
4 Receiver's firm, Simon Consulting, LLC.

5 3. Pursuant to this Court's *Order Re: Petition No. 1*, the Receiver has engaged the
6 services of the law firm of Guttilla Murphy Anderson, P.C., of Phoenix, Arizona, and the
7 Receiver has agreed to pay the law firm compensation at agreed hourly rates for the services
8 of the firm together with all reasonable costs and expenses incurred on behalf of the Receiver.

9 4. Pursuant to the Court's *Order Re: Petition No. 2*, the Receiver is authorized to
10 file this fee petition without including as exhibits the itemization of services rendered to, and
11 costs incurred or expended on behalf of, the Receivership, provided that the fee petition
12 includes a statement that anyone desiring additional information concerning the services and
13 costs to be paid under the fee petition may obtain redacted information from the Receiver by
14 delivering to the Receiver and the Receiver's counsel, Guttilla Murphy Anderson, P.C., a
15 written request specifying the additional information requested at least three (3) days prior to
16 the date set for any hearing on the fee petition. The Court's *Order Re: Petition No. 2* further
17 provides that upon request of the Court, the Receiver shall make available for in camera
18 review by the Court the itemized statements and supporting documentation for the services
19 and costs to be paid under the fee petition.

20 5. The Receiver has submitted an itemized statement for services rendered to this
21 Receivership by the Receiver and his firm, Simon Consulting, LLC, and for reimbursable

1 costs incurred or paid during the period June 1, 2018 through June 30, 2018. The total
2 amount requested for payment by the Receiver is \$10,097.70. The Receiver believes that this
3 amount is reasonable and should be paid from the Receivership Assets.

4 6. The law firm of Guttilla Murphy Anderson, P.C., has submitted an itemized
5 statement for services rendered to this Receivership and for reimbursable costs incurred or
6 paid during the period from June 1, 2018 through June 30, 2018. The total amount requested
7 for payment by the law firm of Guttilla Murphy Anderson, P.C. is \$21,217.48. The Receiver
8 believes that this amount is reasonable and should be paid from the Receivership Assets and
9 has therefore approved this statement for payment.

10 WHEREFORE, the Receiver respectfully requests that the Court enter an order
11 authorizing the Receiver to pay from Receivership Assets:

12 1. The amount of \$10,097.70 to Simon Consulting, LLC, for services rendered to
13 the Receivership and costs incurred during the period from June 1, 2018 through June 30,
14 2018; and

15 2. The amount of \$21,217.48 to Guttilla Murphy Anderson, P.C., for services
16 rendered to the Receivership and costs incurred or paid during the period June 1, 2018
17 through June 30, 2018.
