UPDATE on 2015 Conference by Chaplain Edie DeVilbiss Finch
Louisiana Methodist Children’s Home

When I made the reservations for the Solomon Episcopal Center, I simply knew the beauty and wildness of the area in which it is located. I had never actually visited that particular site. So, in December I went by to check it out. I was impressed. Frank Hall, our host, is genial and accommodating. He explained that the center had been built with the intent of being a retreat center. As such, the cooling equipment is designed to be as quiet as possible. The grounds are thoughtfully laid out and ideal for

contemplative walks.

The chapel is serene. The bedrooms are minimalist, simply a bed and dresser. There are no locks on the doors. For convenience sake, coffee and light snacks are available in the kitchen area at all times. The main building has a comfortable common area, with seating for conversation. There will be a meeting room for us as well. Frank said that we have Wifi available. However, the cell phone coverage in the area is quite limited. He said that texts were more reliable, but even they are sometimes lacking. He provides VOIP for long distance. The suggestion is that we plan to be as disconnected from our workplace as possible, to minimize stress.

I am hoping and planning to utilize the agency van for four days, Monday through Thursday, in order to shuttle people to and from the airport. Please let me know your flight schedule as soon as you have it. Our location is quite remote. That means, if there are items that you forgot or need to pick up, it will be best to plan a stop on the way in from the airport. We will be miles from the nearest drugstore.

It would be sad to come all this way and not tourist a little in New Orleans. My suggestion is a tour of a plantation home in the morning and a visit to the French Quarter in the afternoon. We can make a reservation and all meet for dinner at a restaurant in town. Please let your board members know what you want, so that they can make the best decision for all involved. I am so looking forward to sharing Louisiana with you!

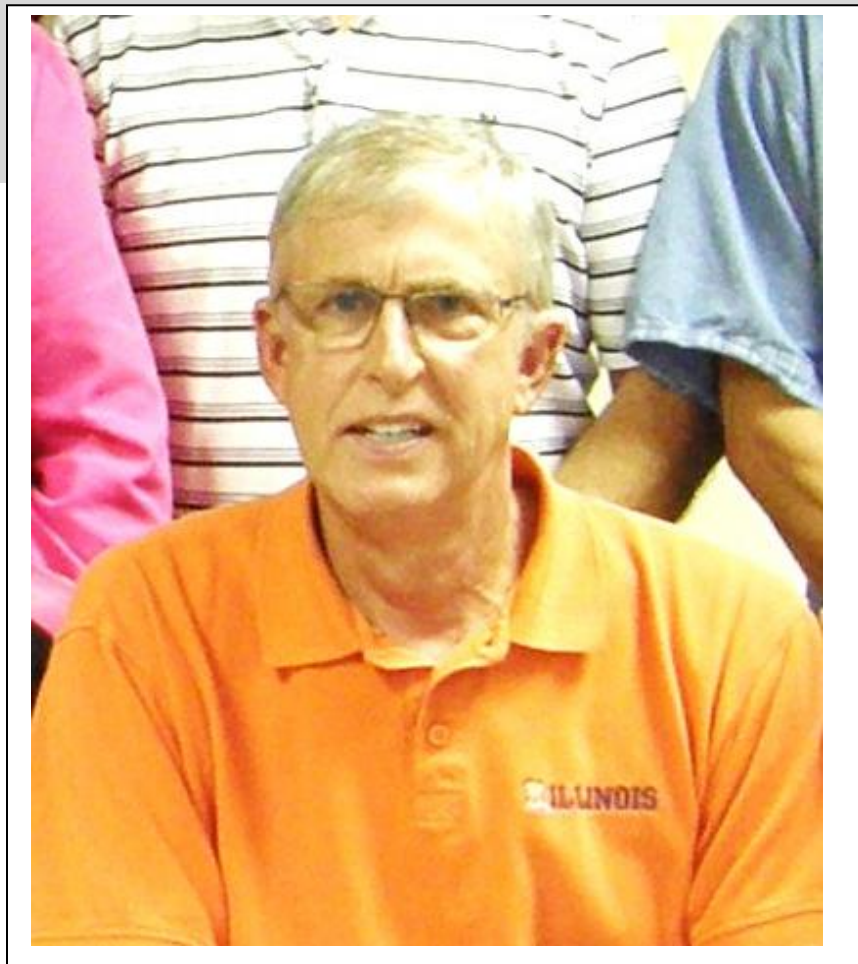

What can we do with this information??

This list includes more than 300 Children's Homes in the nation. It is not complete (I know of a few agencies in my state (including mine!) that are missing from the list.) But it offers NCAJR the opportunity to discover new associates in ministry around the country. It gives ministers to youth at risk the opportunity to hear from us and to join our network of ministers with troubled youth. This list could easily double or triple the size of our current communication network (about 80 associates). But we need to make these contacts.

Make contact with every agency in your state and ask if they have a minister on staff or a volunteer who is entrusted with the spiritual care of the youth. Secondly, ask that person if they would like to receive our quarterly journal by email (and if so, get the email address).
