- Glanbia cheese plant has received awards for being a driving economic force in mid-Michigan.
- The Clinton County Public Safety Radio Project millage proposal will be on the March 10, 2020, ballot. If approved, the millage of .85 mills will generate approximately \$2.5 million annually to fund the 911 Center Operations.

Township Assessor Beth Botke

- Permits for 2019 included: 9 new residence, 2 residential additions, 4 residential garages, 5 utility buildings, 1 deck, 2 pools, 2 demolition permits, 1 solar panel, and 4 partial construction permits from prior year.
- PA Bill 116, 117, 118 and Residential Solar Panels Exemption were signed in November 2019.
- The Board of Review met on December 10, 2019 and had 4 Principal Residence Exemptions (PRE) and 1 Ag.
