## AMELIA VILLAGE, OHIO Resolution R-2015-02

## A RESOLUTION AUTHORIZING AMELIA VILLAGE TO PARTICIPATE IN THE OHIO DEPARTMENT OF TRANSPORTATION (ODOT) COOPERATIVE PURCHASING PROGRAM

WHEREAS, Pursuant to Revised Code Section 5513.01(B), which provides the opportunity for municipal corporations to participate in contracts of the Ohio Department of Transportation for the purchase of machinery, material, supplies or other articles.

**NOW, THEREFORE, BE IT RESOLVED**, by the Council of Amelia Village, Clermont County, Ohio, a majority of its members concurring:

**SECTION I.** That the Mayor hereby requests authority in the name of Amelia Village to participate in the Ohio Department of Transportation Summer (418-16) and/or Winter (018-16) contracts for road salt.

**SECTION II.** That the Mayor is hereby authorized to agree in the name of Amelia Village to be bound by all terms and conditions as the Director of Transportation prescribes.

**SECTION III.** That the Mayor is hereby authorized to agree in the name of Amelia Village to directly pay the vendors, under each contract of the Ohio Department of Transportation in which the Amelia Village participates, for items it receives pursuant to the contract.

**SECTION IV.** That Amelia Village agrees to be responsible for resolving all claims or disputes arising out of its participation in the cooperative purchasing program under Section 5513.01(B) of the Ohio Revised Code. Amelia Village agrees to waive any claims, actions, expenses, or other damages arising out of its participation in the cooperative purchasing program which Amelia Village may have or claim to have against ODOT or its employees, unless such liability is the result of negligence on the part of ODOT or its employees.

**SECTION V.** Village Council hereby finds and determines that all formal actions relative to the passage of this resolution were taken in an open meeting of this Council, and that all deliberations of this Council and of its committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with applicable legal requirements, including Section 121.22 of the Ohio Revised Code.

**SECTION VI.** That this Resolution shall take affect and be in force from and after the earliest period allowed by law.
