# Spousal Rights of Retiring Postal Employees

One of the new things affecting the families of postal workers is an early retirement package. The spouse of a retiring postal worker has some rights you need to know about, including the spousal annuity. You must sign and have a form notarized if you do not wish to receive health care benefits

and a portion of the retirement annuity in the event of your spouse. Know what you are signing before you sign your benefits away.

## **Survivor Annuity Elections (OPM.GOV)**

"If annuitants are married at the time of retirement, they must provide maximum survivor benefits to their spouses unless their spouses consent to an election of less than a maximum survivor annuity. An annuitant elects a survivor annuity for a spouse at retirement on the retirement application and an election results in a reduction to the annuitant's monthly annuity for purposes of paying for the cost of the survivor annuity amount elected.

## **Monthly Annuity**

A monthly annuity may be payable to a current spouse, former spouse (if a retiree elects this benefit or if it is awarded by court order), a minor child, a disabled dependent, and/or a student. Creditable service and length of marriage

requirements must also be met. (OPM.gov)"

The Social Security Fairness Act eliminating the WEP and GPO offsets was passed due to the hard work of APWU and Auxiliary members, retirees, other unions, and the general

public. Everyone worked together to get this bill passed that had been unfairly on the books for over 20 years. History shows us that grassroots initiatives work.

With that said, we have a lot of work to do. Our mission is to assist the APWU in addressing issues that affect us, the APWU, the postal service, and postal retirees. It's essential that, as a group, we do not get bogged down with all the tribulations that are going on right now.

Working together, brainstorming, and concentrating on just those issues that the APWU backs will keep us on track.

Remember the old Aesop's fable, The Father, His Sons, and the Bundle of Sticks? The sons were fighting with each other when their father handed the oldest son a bundle of three sticks. He instructed his firstborn to break the bundle, which the son could not. His brothers tried to break the bundle as well, and failed. The father then handed each boy one stick and told them to break it. Each son was able to break their stick in half easily.

The lesson that day was that sticks in a bundle can't be broken, but sticks taken singly can be easily broken. The same applies to people. **There is strength in numbers.** 

Get to know other members, discover their strengths, and recruit them to help. Help with what? Educating other Auxiliary and APWU members, their families, friends, coworkers, customers, and the public about our issues. Concentrate on one concern at a time and make it personal. People will be the most supportive of those issues that hit home.

The effects of privatization are not always known. Sometimes, when a person is having problems receiving their mail on time, having restricted access to a post office, long lines, and payments arriving late, and they do not have a clear idea as to why, they might see privatization as having to be better than what they are experiencing.

It is up to us, all of us, to be educators. Give examples of how privatization will impact the person you are talking to. For example, do they live in a rural area, own a small business, receive medicines in the mail, or send valuables? We, of course, need to be knowledgeable ourselves.

We are forming a legislative committee of officers and members to start things off. The committee members will discuss communication avenues to reach as many people as possible. Talking points will be formulated to help us in the field.

# Legislation in the 119th Congress




One of the first bills of 2025 affecting the postal service is H.R. 1249. The intent of H.R. 1249 is to require the United States Postal Service to post notices of changes that will affect nationwide postal services and other purposes. Still in the initial stage, H.R. 1249 was introduced in the House by Representative Harriet Hageman (R.WY) on February 12, 2025.



Representative Stephen Lynch introduced House Resolution 70 on January 28, 2025. H.Res. 70 expresses "the sense of the House of Representatives that Congress should take all appropriate measures to ensure that the United States Postal Service remains an independent establishment of the Federal Government and is not subject to privatization." It is important to note that this is not a bill that would become law if enacted. A resolution, if adopted, states the will and intent of the House, the Senate, or the entire legislature. A resolution is an important measure as it gives us an idea of how the members of Congress feel about specific issues. H.Res. 70 has 102 co-sponsors and is in the Oversight and Government Reform Committee.



The APWU still backs legislation allowing the Postal Service to ship beer, alcohol, and wine directly to consumers. The USPS Shipping Equity Act (H.R. 3721) from the 118th Congress did not make it out of the Oversight and Government Reform Committee. We will keep urging our Senators and Representatives to pass legislation that would make the Postal Service more competitive with the private sector and provide more revenue opportunities.

## RULES & GUIDELINES - FOR THE 2025 SCHOLARSHIP

- 1. NO 2025–2026 high school graduates will be considered for the 2025 scholarship. Applicant MUST have had a break from High School of one year or more.
- 2. Applicant must be a member in good standing with APWU National Auxiliary. The applicant must have been an Auxiliary member in good standing for at least one (1) year prior to the application deadline.
- 3. Application must be on the official application form from the APWU National Auxiliary Continuing Education Scholarship Program.
- 4. Applicant must write an essay on the designated subject of no less than 175 and no greater than 250 words.
- Completed application form with the essay must be mailed or e-mailed to Chairperson Barb Maciejewski (the address included with instructions) postmarked July 1, 2025.
- 6. Applicant must be registered, enrolled, or attending an accredited college (college, university, vocational or technical school, etc.) at the time the scholarship is given.
- 7. The APWU National Auxiliary will award one (1) yearly scholarship of \$1000.00.
- 8. After verification, the recipient has enrolled with the school of their choice. The award will be sent to the business office of the school. The funds can be applied to the cost of books, food vouchers, or tuition. Scholarship must be used within 18 months of the award date.
- 9. The scholarship recipient is eligible to receive one (1) yearly scholarship for a maximum of two (2) years upon reapplication & selection process in accordance with the rules and guidelines of the scholarship.
- 10. If the recipient drops out before the completion of the course(s) (and within the refundable time frame), any unused funds that have already been sent to the recipient school for continuing education shall be refunded back to the National Auxiliary to the APWU.
- 11. No APWU Auxiliary National Executive Board member or family will be eligible for this scholarship.
- 12. No exceptions will be made to these rules.

# **Bad to Worse?**

The future of the Postal Service is up in the aireven higher than before. Louis DeJoy announced his resignation on February 18, 2025. The Board of

Governors will now look for a successor to the 75<sup>th</sup> Postmaster General. It is uncertain if this will be a positive move for the 640,000 Postal Workers, their families, and the general public who depend on their mail daily or a detriment. DeJoy mentioned in his closing letter that his 10 -year plan is firmly in place for the new Postmaster General to step in.

DeJoy has been leading our National Treasure as if it were a business instead of a service to the American people. His "Delivering for America Plan" calls for consolidating distribution networks, resulting in mail traveling sometimes hundreds of miles just to be processed and lessening trucks to such a great extent that post offices over fifty miles from a distribution plant will be or already have been cut down to one truck a day.

Has DeJoy been setting the postal service up for privatization? Will the next Postmaster General follow in his footsteps?

We also have no idea how long it will take for a successor to be voted in if they have any experience or knowledge of the Postal Service or pre-conceived ideas to tear it down piece by piece.

Or, maybe, the new administration has other plans entirely. Maybe, getting rid of the Board of Governors?

We are heading into the unknown.

# Ask us! ABOUT MEDICATION ADHERENCE

Anything we do on a regular basis – whether it's making a monthly car payment or taking a daily medication for an ongoing health condition - requires us to think about how well we do it and make sure we stay on track.

#### WHAT IS MEDICATION ADHERENCE?

Adherence can actually be measured and is traditionally defined as **taking a medication as prescribed at least 80% of the time**. This may seem easy to accomplish, yet nearly 50% of Americans do not achieve it!

We tend to over-evaluate our own compliance and may not realize how many doses we actually miss over time. Even if the goal of 100% adherence is not achieved, we need to follow a prescriber's orders and take our medication an average of at least 6 days out of every week to surpass the 80% threshold.

Taking a medication as directed gives us the best chance of experiencing the most benefits and improved quality of life. Managing a chronic medical condition can provide healthier outcomes both now, and in the future. Knowing this, let us be motivated to manage the various factors which can lead to non-adherence.

### WHAT ARE COMMON OBSTACLES TO PROPER MEDICATION ADHERENCE?

- Forgetfulness (busy, distracted, low priority)
- Cost
- Complicated dosing regimens
- Incomplete understanding of medical condition
- Unclear clinical goals or endpoints
- Absence of noticeable symptoms
- Concerns about side effects


Patients do not take their medicine *as prescribed* about half the time.

#### **HOW MIGHT SOME OF THESE CHALLENGES BE SOLVED?**

- Organize medications (pill box, strategic location)
- Reminders (calendar to-do list, phone alarm)
- Recruit a friend or family member to help keep you on track
- Simplify dosing regimens
- Fewer # of tablets (combination pills, if appropriate)
- Fewer doses per day (once/day dose, if possible)
- Fewer trips to pharmacy (3-month supply and/or delivery)
- Understand clinical goals (ex., blood sugar levels)
- Recognize positive benefits of staying adherent as motivation
