Notice to Exhibitors

1. Entries Close at 6:00 PM MST, March 9, 2022, after which time entries cannot be accepted, canceled, changed or substituted, except as provided for in Chapter 11 Section 6 of the Dog Show Rules, and no entry fees will be refunded. There will be a \$2.00 fee charged for cancellation of an entry prior to the closing of entries.
2. Entries not on Official AKC Forms or photocopies of entry forms without the agreement and rules on the reverse side of the Official AKC entry form are not acceptable. Entry Form must show the name of the Club and the date of show.
3. Dogs need be present only for their judging. Dogs not needed for further judging may be removed from the show grounds.
4. It is advised that owners and agents be familiar with the Agreement on the reverse side of the entry form.
5. To transfer a dog from one of the regular classes to the next level in competition requires that the owner or agent notify the Show Secretary at least one half hour prior to the judging of the first class at this show.
6. The entry forms in this premium list may be used for both shows. Please check the appropriate box of the show/shows you wish to enter your dog. This eliminates the need to fill out two entry forms for one dog.
7. Entries will be limited to the first 45 people.
