1. Proof of insurance is required with registration form. Vendor must furnish a \$1,000,000 certificate of liability naming North Iowa Fair Association (NIFA) and Cerro Gordo County as additionally insured during Fair. Certificate must be provided by July 10, 2019 and held on-site during Fair.
2. The NIFA, its agents, employees and affiliates assume no risk and shall not be responsible for any damage, injury, loss, legal action or expenses that may arise or come to the exhibitor or his employee, or his goods or property, or to the public from any cause whatsoever. Exhibitor/vendor understands that he/she should carry business/personal liability insurance.
3. The NIFA/coordinator reserves the right to cancel any or all future reservations made by any vendor acting in any manner deemed to be inappropriate.
4. Vendors must be present and set up and during all hours open to the public. No early tear downs.
5. Spaces may not be sub-leased.
6. No dumpster use.
7. Teardown begins at 530pm Sunday.
8. Sales tax: It is the responsibility of the vendor to collect all applicable sales tax and remit accordingly.
