BH Energy LED Street Lights - Libby has a call in for an update, Tabled

Signs – The sign project should be completed by the end of June.

Status of backup well – Still waiting for a bid from Frank Conway with Dakota Bice Drilling. The bid from Taylor Drilling was reviewed. The location of the new well could either be near the baseball field park or adjacent land. Brandon will check with Gingras about selling a piece of land to drill the new well. Both well drillers said there's not enough land where the existing backup well is located. Brandon will try to get another quote for drilling the well, totaling 3 quotes.

The board has decided not to move forward with the new well funding application for the state. Tamra will contact Lysann about the decision.

Mowing bids – The mowing bid from Precision Lawn and Field was approved by the board via email for \$259 per mow.

Plumbing in Pumphouse – Brandon clarified that maintenance in the pumphouse is not an emergency, but repairs need to be done. Tabled until next month

Street cleaning – Tamra will call Valley Sweeping to get on the schedule.

Brandon looked at drainage where the gravel road meets LaRue. No major concerns reported.

Prairey Walkling emailed some questions about the playground equipment.

• The playground equipment installed on Larene Drive was done over 40 years ago.

- The Kay Drive equipment came from a company out of California, it should be posted on the equipment.
- Wood chips came from Forest Products.

New Business:

Michael LaBelle was concerned about the boards decision NOT to maintain the gravel road. He would like the board to reconsider the decision as it gives homeowners a 3rd entrance in and out of the development in case of an emergency.

Libby Usera made a motion to move the board meeting in July due to the July 4th holiday, seconded by Jerry Swane, carried. The board meeting will be moved to Friday, July 12th at 7:00 PM. Tamra will check with the church to make sure this date works and will post the change on the website and on the bills.
