Please Note: <u>ALL</u> swimming pools over 28" -this includes new, pre-existing, and/or temporary pools are required to have a safety alarm. Any outdoor swimming pool, including above ground or in ground pool, **MUST have a barrier** which shall comply with State code regulations [4 feet in height with a locking gate]. A building permit is required before installing new pools, spas, and hot tubs having a depth of more than 28".

The Village must receive a certificate from the electrical inspection agency BEFORE using the pool. **No one may use a pool, spa or hot tub until a certificate of compliance has been issued by the Code Official**. Swimming pool regulations can be obtained by contacting your Code Enforcement Officer at (607) 542-2175.

There will be no warnings issued in regards to this NYS regulation. All must comply or an appearance ticket will be issued and fines can be as much as \$250 for every day the violation exists.

New York State Property Maintenance – (NYSPM) Section 302 EXTERIOR PROPERTY AREAS;

302.1 Sanitation. All exterior property and premises shall be maintained in a clean, safe and sanitary condition. The occupant shall keep that part of the exterior property which such occupant occupies or controls in a clean and sanitary condition.

302.4 Weeds. All premises and immediate exterior property shall be maintained free from weeds or plant growth in excess of 10 inches (254 mm). All noxious weeds shall be prohibited. Weeds shall be defined as all grasses, annual plants and vegetation, other than trees or shrubs provided; however, this term shall not include cultivated flowers and gardens.
