## Minutes of the Board of Directors Meeting

On Friday Night, January 22nd, the first quarterly Board of Directors meeting of 1999, was held at the Post. At the last meeting, held on October 5th, three motions that pertain to building improvements were passed: 1) to obtain estimates for a wrought iron gate; 2) to obtain estimates to repair our sidewalk and; 3) to obtain estimates to repair the chairs in the hall. To date no action has been taken by the Board on any of these passed motions.

Board President Richard Reichart announced that the Lounge may have to be shut down due to the lack of volunteer's needed to bartend and clean-up. It seems that the current lounge manager's, Bob Knapp and Frank Gissi, can no longer find the time to volunteer their services on a regular basis. Bob Knapp now works on Monday and Friday nights, while Frank Gissi vacations in Florida, three months a year. A suggestion was made that we find another member (or more) who is willing to take over as Lounge Manager. This suggestion was immediately shot down by the Board President. Richard Reichart said that if volunteer's are found, they would serve as assistant manager's ONLY. Bob and Frank would still be the manager's even if they are hardly around. This means that, if no volunteer's are found, the Lounge would only be open when a manager is present. A few board member's protested this type of arrangement. Ferdie Salvatore suggested that the board members meet with Bob Knapp and Frank Gissi to resolve this problem. (Editor's note: A few days after this board meeting, a few volunteers came forward. The new arrangement is as follows: Leo Milham will co-manage the lounge with Bob Knapp. The new lounge staff will consist of Jerry Quinn, Dennis Conroy and the "Spider". Any other members who would like to volunteer are welcome.)

Corporation Treasurer Paul Zalesak suggested that notification of future board meetings to the members of the board be made by telephone instead of by letter. After a brief discussion, the board decided to try this procedure on a trial basis. If it works to the members satisfaction, then a change must be made to the Association's By-Laws in Article V, Section 4, which currently reads: "At least three days written notice of all meetings shall be given each member of the Board".

The next Board of Directors meeting is scheduled to be held in April.

#### \* \* \* Veterans Insurance Hoax \* \* \*

The following was provided to the Post by the Borough President of Staten Island, the Honorable Guy V. Molinari.

"A chain letter which falsely encourages veterans to write to the VA in Philadelphia, PA to collect a dividend on GI insurance they had while in the service, has continued to pop up on Staten Island and around the metropolitan area. Typically, the letter says that veterans will not receive the entitlement, unless they "ask the VA" for it by writing a letter to the Philadelphia Insurance office. I am attaching a sample of this misleading chain letter, in hopes that you will not be fooled if it emerges at your post, senior center, union bulletin or community center."

Bill Passes Entitling Monetary Return to Veterans
If you are a veteran, or if any of your relatives fall under that category, you may be interested in the following information.
A bill was recently passed by Congres entire ing veterans to a dividend on the GI Insurance they had while in the service. Bo n current and former military personnel are entitled to this dividend regardless of whether or not they shall carry the insuance. If you are eligible, you will NOT eccive the dividend unless YOU ASK for it. The Veterans Administration will review each individual case and determine eligibility. A general schedule of dividends a trued is as follows:
2 YEARS OF SERVICE: \$251 , 3 YEARS OF SERVICE: \$391. 4 YEARS OF SERVICE: \$528.
To apply for the dividend, write to the VETERANS CENTER, P.D. BOX 8479 PHILADELPHIA, PA. 19101
REMEMBER: The veterans administration will not automatically send you the dividend. You must apply for it. Complete Form Below




