
## Training is "free" for February & March/2025. No registration required.


## "The only thing harder than gaining a person's trust is trying to get it back once it has been broken."

The rebuilding of relationships is an essential quality for all Servant Leaders of the Lord. Whether the relationship that needs mending is Pastor/Leader, Leader/Leader, or Leader/Member, every leader will, at some point-in-time need to rebuild trust that has been broken by their ministry leadership.

My Church Hurts (Pt. 2) uses the lessons of Apostle Paul to Timothy in 2 Timothy 2 (2-Tim-2) to teach today's Servant Leaders how to...

- 1. Rebuild: Start the Process to Mending Broken Trust
- 2. Replace: Fill Voids of Emotional Hurt with Spiritual Hope
- 3. Restore: Forgive Self & Others for What Has Taken Place

Whether the mistakes are made by you or others, they (mistakes) are inevitable, but continued hurt is optional. Choose to receive and spread the healing that comes from being a servant of the Lord.

"And" indicates Servant Leadership that is consistent with the Spirit. "But" is an indication of a Church Leader whose actions sometimes contradict the Spirit. Which word best describes your leadership?

Servant leadership must always be consistent with your spirituality. Being spiritually connected in your leadership is what differentiates "Servant Leadership" from "Church Leadership". Many leaders feel that their ministry titles and positions authorize them to act and speak in ways that are contradictory and inconsistent with the Spirit of Christ.

Spiritual Gentleness is "De-escalation and Conflict Management Training" for Servant Leaders desiring to lead ministry and facilitate meetings by the Spirit. What will you learn?

- 1. Church Meeting "Priorities": Respecting the "Convictions" of Others
- 2. Church Meeting "Discussions": The Spirit of Disagreeing vs. Arguing
- 3. Church Meeting "Leading & Participation": The expectation is "And" Not "But". Leading and being present in the Spirit of the Lord.

The purpose of "spiritual vision" is to unite the different parts of the Body to walk in the same spiritual direction. Spiritual visioning answers the question, "What would the Lord have us to do?"

Pt. 3 of the "Whole Church" Church Meeting Training series teaches Servant Leaders the three spiritual essentials for vision casting in Church Meetings.

- 1. Pastor and People Being Guided by the Spirit of Christ
- 2. The Pastor's Willingness to Lead & Cast God's Vision in the Spirit of Christ
- 3. The People's (Congregation's) Willingness to Follow Pastoral Leadership & Vision in the Spirit of Christ

Budgets, finance reports, project funding, and income/expenditure reports are often at the center of many church meeting disagreements. Some budget disagreements are the result of a lack of transparency, organization, and "internal control" of the Lord's money. Other times, the problem is neither the budget nor the finance reports, but the congregation's displeasure with those who serve on the finance/business committee.

CBA1's Church Meeting Training (Pt. 4) teaches the importance of Finance Committee Members maintaining a spiritual relationship with the Lord and the congregation and not just the congregation's money. Servant Leaders will learn three (3) things EVERY congregation should expect from those who Manage the Lord's Money on their behalf BEFORE the Church meeting takes place.

- 1. Accountabilities: Spiritual, Moral, & Ethical
- 2. Pre-Church Meeting Responsibilities: Budget Reviewing, Revenue/Expenditure Updating, Bank Account Reconciliations
- 3. "Ownership" of Funds: Finance leaders manage, but do not "own" the Lord's tithes.
- 4. Post-Church Meeting Finance Requirements: Not all questions can be answered during the Church Meeting. Some require follow-up afterwards.

Come learn the responsibilities EVERY Pastor, Finance Committee, and congregation member should learn about Budget Presenting & Finance Reporting.
