Mayor Jack declared the executive session in order at 6:55 PM.

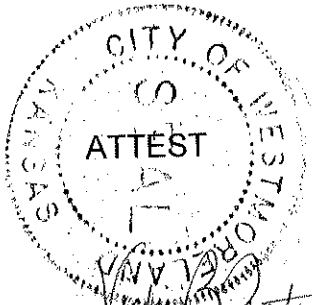


There was no action taken as a result from the executive session.


Councilmember Rice moved to adjourn the special meeting at 7:30 PM.
