

## **Agreement to Participate**

Camping is a vigorous, energetic experience. Participants need to have normal health, strengths, and endurance.

Activities can include running and exploring along bush trails and creeks, water sports, swimming, games of strength, rigorous field group games, climbing wall, hiking, climbing and repelling, use of sharp craft tools, use of bow and arrow, playground equipment, lake watercraft use (canoeing, paddle boating, kayaks, power boating, tubing, knee boarding, waterskiing), water trampoline, paintball, vehicle travel to and from activity sites (power boating activities are for teen camp only). Depending on camp attending there may be travel to and from Grande Prairie area. I/we, the undersigned, recognize that there are risks of injury and/or loss associated with such a camping program. Sturgeon Lake Bible Camp's staff makes the safety and well being of each camper a top priority, however the possibility exists that injuries/loss may occur. Those risks include, but are not limited to broken bones, minor cuts, abrasions, sprained joints, bee stings, animal attacks, major cuts, concussions, drowning, and even death. With many children and youth together in close proximity it is possible for certain illnesses to transfer from one camper to another. They can range from colds and flu's to strep throat and chicken pox or even lice.

### **EXPECTATIONS OF THE PARTICIPANT CAMPER**

Campers are expected to listen carefully and to obey the rules given at the beginning of the camp week and each activity session by the person(s) in charge, and assist by informing/calling attention to situations which may cause injury for oneself and other participants, not feeling well, or fatigued, not being able to master the skill, etc..

### **ASSUMPTION OF RESPONSIBILITY**

I/we the undersigned parents(s)/guardians assume the responsibility for injuries to my child/children in my care while at Sturgeon Lake Bible Camp, and I will not bring action for damages which might arise from these injuries.

### **PARENTAL PERMISSION**

I/we the undersigned parent(s)guardian(s) of the registering camper, acknowledge that I/we have read the above paragraphs, have completed the registration form and medical information fully and truthfully, and give permission for the registering camper to participate in their camp week at Sturgeon Lake Bible Camp. I/we give permission for the Camp Nurse, or the designated medical person to administer as needed the medications listed therein at dosages listed therein (ie. According to the instructions on the packaging), unless directed otherwise in the camper's written medical information supplied by parent(s)/guardian(s) at registration or on the day of arrival. I/we also give permission to the Director and/or camp nurse to approve and obtain medical attention necessary to the campers welfare and good health. If such a situation were to occur, the camp will attempt to notify the parent(s)/guardian(s) or other emergency contact(s), as soon as possible. In the case of accident or illness, the participant must pay for any emergency transport and hospital/physician/medical expenses. I/we also give Sturgeon Lake Bible Camp permission to use pictures/videos that may be taken of the camper during the camp week for promotional purposes.
