

**ELDRED TOWNSHIP, MONROE COUNTY, PENNSYLVANIA**  
**ORDINANCE NO. 01, 2016**  
**AN ORDINANCE AMENDING THE ELDRED TOWNSHIP ZONING ORDINANCE BY**  
**AMENDING THE DEFINITION OF WATER EXTRACTION/BOTTLING**

**WHEREAS**, the Eldred Township Board of Supervisors is authorized pursuant to 53 P.S. section 10609 of the Pennsylvania Municipality's Planning Code to amend the Township's Zoning Ordinance; and

**WHEREAS**, the Eldred Township Board of Supervisors desire to amend the definition of water extraction/bottling contained in Article III, section 303, the "definition" section of the Zoning Ordinance adopted May 1, 2014;

**WHEREAS**, after public notice and a public hearing required by applicable law, the Eldred Township Board of Supervisors believes the following amendment is in the best interest of the public health, safety and welfare;

**NOW, THEREFORE, BE IT ENACTED AND ORDAINED BY THE BOARD OF SUPERVISORS OF ELDRED TOWNSHIP**, Monroe County, Pennsylvania, and it is hereby enacted and ordained under the authority of the same as follows:

**SECTION I**

Article III, Section 303, Definitions, the term Water Extraction/Bottling- is amended to remove the words "manufacturing light" and replace those words with the word "industry", so that the definition of Water Extraction/Bottling shall now read; "any use which involves the pumping or removal of water from groundwater sources, with or without bottling for retail or wholesale sale. Considered industry for the purposes of regulation by this Ordinance."

**SECTION II**

Except as amended hereby, all provisions of the Eldred Township Zoning Ordinance shall remain in full force and effect. Furthermore, the provisions of any other existing ordinances or part of ordinances in conflict with this ordinance, to the extent of such conflict, and no further, are hereby repealed. If any part of the provisions of this ordinance shall be held to be unconstitutional, illegal, or invalid, such unconstitutionally, illegality, or invalidity shall not affect the validity of any of the remaining provisions of this Ordinance or other provisions the Eldred Township Zoning Ordinance.

Duly ORDAINED and ENACTED this 16 day of March, 2016, by the Board of Supervisors of Eldred Township, Monroe County, Pennsylvania, in lawful session duly assembled, same effective five (5) days after adoption or as soon hereafter as allowable by law.
