CALL TO ORDER

Mayor Bolt called the meeting to order at 6:06 p.m.

MINUTES

Commissioner Mason made a motion to accept the previous meeting minutes as presented. Commissioner Camuel made a second to the motion and the motion carried.

PUBLIC COMMENTS

Ms. Stinson requested the tree at the bottom of the front hill be trimmed back or removed because it caused an obstruction when attempting to pull on to U.S. 60.

Other items discussed were:

Grass being thrown onto the street when lawns are mowed...it is creates a slipping hazard when wet and is unsightly.

Parking in the street for long periods of time causing safety issues and being inconsiderate of neighbors and city traffic is an issue at times.
