

### **Prospect House Treatment Outcomes: 1990-2015**

### Period One: 1990-2000

- Contacted residents from the ten year period
- Interviewed using standardized questions:
- What is your current state of sobriety?
- Have you had contact with the criminal justice system since leaving treatment?
- Do you attend a support group (e.g. AA meetings)?
- Assessed qualitative aspects of their lives since leaving treatment

<sup>\* 21</sup> participants in sample were incarcerated: no data on their status available



#### Period Two: 2001-2015

- Studied residents on roster as of June in each of these years using validated "Case-Study" Techniques
- Individuals classified "Sober" based on personal assessment, peer evaluation, and successful functioning
