BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHAPIN, MORGAN COUNTY, ILLINOIS:

SECTION 1: That there be and there hereby is appropriated for the fiscal year beginning May 1, 1984 and ending April 30, 1985, the sum of Two Hundred Sixty One Thousand Eight Hundred Fifty Dollars (\$261,850) for the corporate purposes and amounts herein set forth, including all sums of money now in the hand of the Village Treasurer:


