 Hillsborough County typically invests about \$8 million annually in direct client services that includes the Low-Income Home Energy Assistance Program (LIHEAP), Emergency Home Energy Assistance Program (EHEAP), Community Services Block Grant (CSBG), and Rental/Mortgage Assistance programs. These programs have been in place for Hillsborough County residents, regardless of jurisdiction, before COVID-19 and will remain in place.

The funds can be used to pay past-due utility bills and/or lease/mortgage payments in the name of the person applying for assistance. For instance, if the electric bill is in your spouse's name, your spouse must be the one to apply for R3 assistance with Social Services. All Hillsborough residents can call the Rapid Response Assistance Call Center at (813) 274-3710 beginning on Monday. The call center will be open from 8 a.m. until 5 p.m. Monday through Friday.
 Residents who have been affected by COVID-19 but would have qualified for Social Services assistance prior to the pandemic will be assisted through Social Services' LIHEAP/EHEAP and Housing Assistance programs just as they always have.
