AN ORDINANCE OF THE TOWN OF PIERSON, FLORIDA, AMENDING THE TOWN OF PIERSON UNIFIED LAND DEVELOPMENT REGULATIONS, ARTICLE V, SECTION 5.5.11, B-2, HEAVY COMMERCIAL AND INDUSTRIAL DEVELOPMENT CLASSIFICATION, B. PERMITTED PRINCIPAL USES AND STRUCTURES, BY ADDING FERNERIES AND HORTICULTURAL NURSERIES; PROVIDING FOR SEVERABILITY; REPEALING ALL LAWS OR PARTS OF LAWS IN CONFLICT HERewith; AND PROVIDING WHEN THIS ORDINANCE SHALL TAKE EFFECT.
