- **A** Yes! The Lancaster Subdivision Association (LSA) Board of Directors has contacted the Macomb County DPW to request that they install a fence for safety. They have denied our request. The board is investigating further. We ask that interested homeowners contact the DPW (586-469-5325) to show support for our request.

Be Smart and Be Safe!

A summary of Lt. Paolella's presentation from the 2007 Annual Meeting. When you are out of town:

• Use light timers, vacation hold for mail and newspapers.

All of the time:

- Install and use deadbolt locks on your doors
- If you have a home alarm, use it *every time* you leave the house and when you go to sleep.
- Keep your garage door closed and lock the service door to the house
- Be aware of unusual/suspicious persons or vehicles in the neighborhood. Report to Sheriff's Department.
- Note that door-to-door solicitors must have a permit. No current permits have been issued for individuals to sell door-to-door. Sometimes thieves pose as solicitors to check out the neighborhood before they strike!
