

There we were in June 1973 ... at last, the moving day! So excited with our 14 month old son, Dimitri Jr., and our toy poodle, Mamselle, to move into our new home. Our home was built in 1939 and the original builder, Howard Gray, came to visit one day to see what we had done. He explained he finished the house in February when he and some of his friends all worked together and built their homes here in the neighborhood. All traded out their different skills, Mr. Gray specializing in stone masonry and cement work. (Thus, the cement driveway which is the original still intact, and my massive stone patio and cut stone walls in the backyard). Many family and friend functions have since been and continue in our wooded backyard.

Our children, Christian, David and Joy Elizabeth, followed our move here in 1976 and 1978. All of our children went through the Penn Hills School system...Forbes Elementary, Linton and Penn Hills High School. Both Christian and Joy received scholarships from the Rotary Club of Penn Hills. All children went on to further their education: Dimitri Jr. at Rosedale Tech and Christian & Joy at Slippery Rock University. Sandy served on PTA board all those years, running the Santa shop at Forbes for 8 years and president of Linton PTA for 3 years. She served as president of our own civic club in 1977-78. Sandy said 'As soon as we moved in, I was recruited for the Social Committee and then chaired same the next year. We used to have big neighborhood dinner dances at the Hospitality Inn (now Comfort Inn) every year.'

Before having children she sang at the cocktail lounge at the Hospitality and many other night spots around town. Also, at one time Penn Hills had an amateur musical group called the Penn Hills Muses. She sang with the Pittsburgh Savoyards and was a special music guest on Channel 40 for 25 years and continues to use her voice in the area.

'There's just nothing like our neighborhood. When we moved in, none of the mothers worked! We used to go to the park on a regular basis and meet up with packed lunches for the children and just enjoy the day. Also, there is an empty lot next to our home and we would put bales of hay at the bottom and the kids would sled ride. Big wheels were so popular back then and our kids and their friends would come over our house and ride forever in circles in the

driveway while we gals sat on lawn chairs, sipping ice tea and watched the joy of our children having so much simple fun. We didn't even have cordless phones yet! And, get this, for the Easter egg hunts, we all boiled and dyed REAL eggs!! Good grief...a lot of work. I also discovered my typing teacher, my English teacher and my Biology teacher lived here in Crescent Hills!! What more could you ask for?'

Married 54 years and 6 grandchildren (3 girls and 3 boys ranging in age from 7 to 19) we are truly blessed and thankful. Living here 46 wonderful years, neighbors are so great and friendly, caring and helpful. Hope all of you have the same positive experience living in this neighborhood as we have. The only thing different now is WE are the older people we used to refer to as our "older neighbors". HAHA

Some Changes in Crescent Hills Park There will be no park rentals in 2018

There has been a tradition for the last 30+ years that a CH resident could rent the park for parties or picnics. As was mentioned in the fall newsletter (when the community was invited to comment) that tradition has been under review. The park committee has decided that CH park will not be formally rented in 2018. There were many reasons and discussions leading to this decision but it came down to these main two reasons:

- 1. CH park is a small space in the middle of a residential area. It has restrictions like limited parking, no electricity and no flushing toilets. It is too small to accommodate the size of groups that were renting the facility. The noise, traffic and trash resulting from large picnics have been very disruptive for the neighborhood.
- 2. Since renters have had exclusive use of the park, it has restricted use by the rest of the neighborhood for the whole day. People couldn't play with their kids or walk the trail on weekends which is, for many, their only leisure time available.

We welcome the use of our shelter by our residents! The shelter can continue to be used for a small picnic or party without a reservation and without charge. Residents should just know that they won't have exclusive use. They'll share the space with whoever is there walking,

playing or also having a picnic. The usual "ordinance" limitations apply: no parking on the street, keep dogs on a leash, pick up after oneself and keep noise at a minimum.

While this change may force some residents to look elsewhere for a party venue, many more will be free to use the greenspace of the park at a more convenient time for them.

Port-a-John to replace Park Outhouse Use

Another major change in the CH park is that the outhouse will no longer be used. In April, it'll be locked and "boarded up" due to sanitation reasons. There will be a rented port-a-john located (most likely) in the tree grove at the end of the parking lot closest to the field per the rental company's preference.

The Proposed Penn Hills Town Center and Memorial Park

The municipality has asked for the Civic Association's input as to the Town Center and Memorial Park that is proposed to replace the current municipality building. The municipal plan is to seek grants over a period of three years, each at \$250,000, to demolish the building and replace it with a gazebo, walking paths and landscaping. The architect's rendering makes a beautiful space that we would welcome as the place where a review stand would be assembled and the Memorial Day parade stop. One can imagine that the area could be used for other events and maybe even farmer's markets.

However, recent decisions by the municipality have made it less likely that the area would be a "memorial" park as we understand that all the memorials, not just the police memorials, will be moved to the new building. Perhaps the Christmas tree can still be at this location, however, that would necessitate the provision of electricity. Likewise photos with Santa could not take place outdoors and a heated tent may have to be procured for the event.

The Civic Association still considers the current municipal building to be a classic and historic landmark. We are not opposed to the reuse of the building, especially the newer portion, as apartments or office space. It would benefit the municipality to have such a prime piece of property added to the tax rolls. If it were possible to find a buyer for the newer building, it is imaginable that the older portion of the building could be demolished and then only that smaller area would serve as a community park, with a gazebo and green space.

These comments should not be used to dissuade the municipality from proceeding to apply for grants. However, these comments are made so that other options may also be considered.

Code Update for Penn Hills

Any resident of PH contemplating the need to store personal belongings outside of their home should understand that there is presently an ordinance that permits the use of PODS. A permit is requited in the amount of \$25.00. The max time is 14 days with the ability to request a hardship from code enforcement. All PODS must be located on a hard surface, such as driveway.

Additionally, the municipality is proposing a new ordinance for the use of dumpsters and bagsters. The permit fee proposed is \$25.00 for either. Dumpster will be regulated to a 30 day period and bagsters for 14 days. All permits required start at the PH Code Enforcement office.

Penn Hills Shade Tree Commission

An article on the front page of the Pittsburgh Post Gazette on Wed. Feb. 28, states that the tree canopy in Allegheny County is in an alarming decline. Unfortunately, it specifically mentioned Penn Hills as one of the communities most affected. The Penn Hills Shade Tree Commission (PHSTC) is a newly formed organization, approved by a municipal ordinance, for the planting and preservation of shade trees, the development and promotion of various environmental projects and to promote educational programs and citizen participation, all of which are intended to help reverse our declining tree canopy.

A shaded, tree-lined, residential street is a beautiful image but do you know that trees are environmental workhorses? Trees give us much needed shade on a hot day, create oxygen for us to breathe and absorb atmospheric carbon. Trees absorb huge amounts of stormwater runoff, decreasing the amount of raw sewage that flows from our overloaded sewage system into the Allegheny River. In addition, trees increase our property values, attract residents and businesses to our community and have actually been shown to reduce crime by fostering safer, more sociable neighborhoods.

The PHSTC's first tree planting event occurred in October when we planted 15 trees at Penn Hills Elementary School. On March 11, we hosted a free tree pruning workshop. On Sat April 14 @ 2 pm, we will have a community Arbor Day tree planting in Penn Hills Park. Also this spring, we will be planting 40 trees along a Penn Hills residential street, our first of many Front Yard Tree Projects! Finally, this summer and continuing into next summer, we will be working on restoring Plum Creek in Penn Hills Park by removing the invasive Japanese knotweed and replacing it with native trees and shrubs. We cannot complete these projects without your help! Please check our website, PennHillsSTC.org for times and dates and make plans to join us!


