Show Display - The art show **winners** will hang from October 4 – 31, 2025.

Art Pick-Up – October 6 – October 10, 2025, during regular gallery hours or by appointment for after hours. **Art show winners pick-up will be October 31 - November 7. Any artwork not picked up during this week, or had other arrangements made with gallery, will become property of Marshall County Art Guild.**

LOCATION: Marshall County Art Guild Gallery & Studio on the Lewisburg square at 107 W. Commerce Street, Lewisburg, TN

CATEGORIES:

Adults - Oils, Acrylics, Watercolors, Pastels, Mixed Media, Colored Pencils, Pen & Ink, Graphite or Charcoal, Photography, 3-D & Functional, Fiber Arts, Sculpture, Computer Graphics.

Youth (All general art, to be judged by grade in school.) - Pre-school – 1st Grade; 2nd -3rd Grade; 4th – 5th Grade; 6th – 8th Grade; 9th - 12th Grade

ENTRY FEES: MCAG members have a \$25 entry fee. Non-Member Residents of Marshall County \$35. Residents OUTSIDE Marshall County have a \$40.00 entry fee. Entrants are allowed five (5) items per category, the entry fee covers all entries. All Youth Categories entries are FREE.

AWARDS: 1st, 2nd, 3rd ribbons for each category. Honorable Mention if the judge chooses; "BEST OF SHOW" for Youth & Adult (Determined by the Judge) & for "PEOPLES' CHOICE" for Youth & Adult (Determined by votes made by the visitors to the gallery).

ELIGIBILITY: This juried competition is open to ALL ARTISTS. Only original artwork conceived by the entrant will be considered. Work copied from any published materials, famous photos or paintings are not eligible. Please research copyright laws for further information about this law, which protects all artists. All artwork must have been completed within the past FIVE (5) years (Oct. 2020 -2025). Entries will be viewed by people of all ages. Appropriate subject matter is required. Artwork entered will be reviewed by event directors before being accepted for eligibility. First Place Winning entries from previous Arts-A-Poppin Shows are not eligible. However, nonwinning entries from the previous show(s) may be resubmitted. Our judge will receive/review a copy of eligibility rules and requirements prior to judging. The gallery will be closed during the judging and the decision of the judge is final.

ENTRY PREPARATIONS: All entries must have a completed ENTRY FORM. **All paintings must be suitably FRAMED WITH A WIRE FROM SIDE TO SIDE ON THE BACK OF THE FRAME for ease in hanging by the gallery staff.** Gallery staff will be available on entry days to assist with artwork log-in. The Marshall County Art Guild will take every reasonable precaution against loss or damage to entries, but will not be responsible for any such loss or damage.

ENTRY DEADLINE: Artwork is to be dropped off at the Marshall County Art Guild Gallery between September 29 - October 1, during regular gallery hours. ENTRIES WILL NOT BE ACCEPTED AFTER THIS DATE. **Each piece of artwork must be ready to display or hang with wire and have a completed entry form at time of drop off.**
