I also further attest to the fact I am not currently under the influence of any substances that may hinder or impede my actions in handling a firearm safely for the intended purposes of this course. BASIC CCW REQUIREMENTS: ALL STUDENTS MUST BRING THEIR OWN FIREARM A SEMI-AUTOMATIC OR A REVOLVER AND MINIMUM 20 ROUNDS (BETTER TO HAVE MORE THAN ENOUGH THEN NOT ENOUGH) PRACTICE ROUNDS. NO LIVE AMMUNITION IN THE CLASS ROOM. **NO EXCEPTIONS!** ALL **MISSOURI** STUDENTS MUST FIRE 20 ROUNDS FOR QUALIFICATION INTO A B27 TARGET FROM 7 YARDS WITH A SEMI-AUTOMATIC OR A REVOLVER. EACH STUDENT MUST SCORE A MINIMUM OF 15 OUT OF 20 ROUNDS ON QUALIFICATION TARGET TO PASS. ALL **KANSAS** STUDENTS MUST FIRE 25 ROUNDS FOR QUALIFICATION INTO AN FBI TQ-15 TARGET. 3 YARDS 1 HANDED SHOOTING 5 ROUNDS, 7 YARDS FREE STYLE 10 ROUNDS, 10 YARDS FREE STYLE 10 ROUNDS. EACH STUDENT MUST SCORE A MINIMUM OF 18 OUT OF 25 ON QUALIFICATION TARGET TO PASS. **NRA QUALIFICATIONS REQUIREMENTS:** 5 SHOT GROUP WITHIN 9" CIRCLE FROM 10'-15', **ROCKER QUALIFICATION:** 5 THREE SHOT GROUPS WITHIN 9" CIRCLE AT 15'.
