

ORDINANCE No. 1, 1966

AN ORDINANCE ANNEXING CONTIGUOUS TERRITORY
TO THE TOWN OF CLOVERDALE INDIANA

SECTION I: Be it ordained by the Board of Trustees of the Town of Cloverdale, Indiana, that the following described contiguous territory be and the same is hereby annexed to and declared to be a part of said Town of Cloverdale, Indiana.

The following described real estate in Putnam County, Indiana, to wit:


Situate in the State of Indiana, County Putnam, and being a part of the Northeast Quarter ($\frac{1}{4}$) of Section One (1), Township Twelve (12) North, Range Four (4) West of the Second Principal Meridian, more particularly described, to wit: Beginning at the Southwest corner of the Chester Davis Addition to the Town of Cloverdale, Indiana as recorded in Plat Book 5, Page 115 in the Office of the Recorder of Putnam County, Indiana; thence South 89 degrees 26 minutes West 112.507 feet; thence North 325.80 feet; thence East 112.50 feet to the Northwest corner of the aforesaid addition; thence South 324.69 feet to the point of beginning containing 0.84 of an acre. Also beginning at the Northwest corner of the aforesaid Chester Davis Addition; thence North 152.50 feet; thence East 275 feet; thence South 112.50 feet; thence East 50 feet; thence South 40 feet to the Northwest corner of Lot Six (6) in said addition; thence West 325 feet to the point of beginning containing 1.009 acres more or less. Plotted and recorded in the office of the Recorder of Putnam County, Indiana, in Plat Book No. 5, Page No. 173.

SECTION II: That this ordinance shall be in full force and effect from and after it's passage and legal publication thereof according to law.
