TENNIS LESSONS & CLUB POLICIES: Please read carefully and be fully aware of all policies below.

Registration & Payment Policy:

Completed lesson registration forms/waiver and full payment is required prior to the deadline March 31st, 2026 in order to secure your spot prior to the start of the outdoor season due to the high demand for private/semi-private lessons. All subsequent lesson payments are due on the day of the lesson, payable by cash or e-transfer only. **No refunds** once a lesson has started.

For e-transfer payments and password acceptance to payment, please send to: rd@topspin.ca and include your completed registration and waiver form.

Cancellation & Rescheduling Policy:

A minimum of 48 hours' notice is required for any cancellations or changes whether your lesson is a private or semi-private lesson.

Cancellations less than 48 hours of your scheduled private or semi-private lesson will be charged in full and must be paid on the same date of your scheduled lesson.

Lessons cancelled due to inclement weather will be rescheduled, and/or resumed the week after and you will be contacted immediately.

In a semi-private lesson, if a player is absent after prepayment, no refund will be issued. The remaining player may: a) choose to proceed as a private lesson and pay the difference owe, or b) cancel the lesson in advance with proper notice so that other player(s) may book the time in advance.

2026 Lesson Rates: Private Lesson (1-on-1): \$70/hr. per player **and/or** Semi-Private (2-3 players): \$50/hr. per player.

Privacy, Conduct & Club Policies:

Recording of lessons is strictly prohibited without **prior written consent** from the club pro or directors of the club.

Unauthorized recording will result in immediate removal from the facility and termination of lesson participation with **no refund**.

Parents/spectators/members must respect **club privacy policies** and **club rules** posted at the club and/or online.

2026 MPTC Club shoe tag must be worn **at all times** on court during the season. Improper attire and footwear are not permitted on court. This includes sandals, Crocs, slippers, barefoot play, cut-off clothing, or tops that do not meet tennis club standards. Proper **non marking** tennis shoes and athletic attire are required at all times on court.

Etiquette: All players are expected to respect their coach, fellow players, parents, club members, and directors of the club at all times during the season. Any disruptive or disrespectful behavior will result in a removal from the court and club if behavior persists. **No refund** will be provided in such cases.
