## TOURNAMENT RULES

- Tournament is open to youth bowlers who are participating in a youth league within the ARUSBC association. Youth Bowlers must have a current USBC membership. Adult Bowlers do not need to have a current USBC membership
- 2. Averages: This is a handicap tournament. Entrants will used their highest certified USBC average base on the following order and criteria:
  - A. Youth Bowlers (Minimum of 12 Games)
    - i. Current Season Average with a minimum of 12 games as of one month before closing tournament date. Youth Coaches should send in either an average sheet or link to online standing sheet.
  - B. Adult Bowlers
    - i. 2023/2024 USBC Composite Average
    - ii. 2022/2023 USBC Composite Average
    - iii. Current Season Average with a minimum of 21 Games as of one month before tournament closing date. Bowlers should send in average sheet or link to standing sheet online.
    - iv. If no average exists, then a "Mean Average" will be used. Women: 120, Men: 150. "Mean Average" for a bowler is subject to change.
- 3. Handicaps will be based on 100% of the difference between the individual average and 230.
- 4. Squads will be limited based on space; entries may be reassigned to a different squad. Additional squads may be added if necessary. All confirmations of times of entries received will be sent to the head coach by email before tournament date.
- 5. The tournament will consist of four (4) person bowling team, Two Adults and Two Youth.
- 6. Awards: The Top two (2) teams in each division will be recognized; with the Youth receiving a plague or trophy while the adults will receive a commemorative certificate.
- 7. All unused expense funds will be placed in the Appomattox River USBC Youth Award/Scholarship fund to be used for future ARUSBC awards and scholarships.
- 8. Tournament bowlers may bowl multiple time in different squads; however, there must be at least two different bowlers on a team.
- 9. All fees must accompany entry form. No squad assignments will be made until fees are paid. Fees will not be returned after the entry closing date. Email entries will not be accepted until fees are received. Fees will only be refunded in the event that the tournament is cancelled. A \$25.00 penalty will be required for any bank returned check.
- 10. Check in time begins 30 minutes before time of shift. All bowlers (Youth and Adult) need to check in with the tournament officials. If a bowler is late, a zero will be given for each frame missed.
- 11. Entries will be divided into three divisions, based on individual or doubles averages. Division may be adjusted based on the number of entries in each division. Divisions are: Divisions 1 Averages 520 and Below; Division 2 Averages 521 to 640; Division 3 Averages 641 and Up.
- 12. Conduct derogatory to the best interest of youth bowling while competing in a tournament play will result in a possible suspension from tournaments. Reference USBC Rule 17d.
- 13. For all Youth & Adult Bowlers: Hats, headphones, ear buds, IPods, MP3 type devices and inappropriate T-Shirts are NOT ALLOWED during tournament competition, used during tournament will lead to a disqualification.
- 14. All other decisions will be made by the ARUSBC Youth Committee and Tournament Director. Protest & Appeals must be filed in writing with 72 hours of the infraction. See USBC Rule 329
- 15. Results of the tournament will be made available on the ARUSBC Website (under the youth page) as soon as possible (normally within 7 days of end of tournament). Notifications will be sent to coaches about the posting.
