

If you enter the same dog in two Obedience classes (e.g. Open B and Utility B) on one day, your entry fee will be \$42.00. The fee will also be \$42 if you enter the same dog in two Rally classes (e.g. Excellent and Advanced). If, however, you enter the same dog in an Obedience class and a Rally class, each entry is \$23 (\$46 for both). Please note that you may submit checks that combine Obedience and Rally entries.

#### **SHOW SITE**

This year's trials will be held in the El Paso County Coliseum's Judging Arena, 4100 East Paisano, El Paso, TX 79905. Detailed directions to the show site will be provided in the Judging Program. It should be noted that there is easy access to the Coliseum from Interstate 10 and from the Patriot Freeway.

## SURFACE AND RALLY RING SIZE

Both rings are fully matted. The Rally Ring will be 40" x 50" in size.

## **PARKING**

There is ample parking space in the El Paso Coliseum parking lot.

#### USE OF JUMP HEIGHT ORDER

Entries in Open and Utility will be arranged according to jump height order, beginning at 4" in ascending order on Friday, January 12, and descending order on Saturday, January 13. Handlers with multiple entries in the same class will be accommodated to the extent possible.

# RING PRACTICE

Ring Practice will be held on Thursday between 4:00 and 8:00 PM and on Friday, Saturday, and Sunday beginning thirty minutes after judging has concluded. There will be a charge of \$ 5.00 for a five minute practice.

#### NOTICE TO EXHIBITORS

TELEPHONE AND UNSIGNED ENRIES CANNOT BE ACCEPTED. Entries not on official AKC forms and photocopies of AKC entry forms without "Agreement and Rules" on the reverse side of the entry forms are NOT ACCEPTABLE.

NO ENTRY shall be made and no entry shall be accepted that specifies any conditions as to its acceptance.

PLEASE TYPE OR PRINT ENTRY FORM CLEARLY to avoid error. The Dog Obedience Club of Las Cruces, Inc. assumes no responsibility for incomplete or inaccurate information on the entry form or for a dog being entered in a class for which he is not eligible.

CHANGES, ADDITIONS OR CORRECTIONS TO ENTRY FORMS must be received in writing by the Trial Secretary, prior to close of entries. Those received by telephone are not acceptable.

ENTRIES CANNOT BE ACCEPTED, CANCELED, ALTERED OR SUBSTITUTED after the entries have been closed.

TRANSFERS (Both Rally and Obedience) ARE ALLOWED: After a dog earns a title, it may be transferred to another class even though the closing date for the trial has passed. This transfer may be requested if, according to the owner's records, the handler and the dog are eligible and the dog has completed the requirements for the title after the closing date of the trial. Transfers from an A to a B class at the same level are allowed. The request for a transfer must be made in writing to the Trial Secretary at least 30 minutes prior to the start of each trial; requests submitted prior to the date of the trial will be accepted.

THE DOG OBEDIENCE CLUB OF LAS CRUCES, INC. may decline any entry for cause or may remove any dog on account of sickness or other cause and no one shall have any claim or recourse against the Club or any official thereof.

ENTRY FEES WILL NOT BE REFUNDED in the event of (1) errors or cancellation of entries after the published closing date, (2) the dog being absent, (3) the dog being disqualified, excused by Veterinarian or Judge, or barred from competition by the Trial Committee, (4) having been entered incorrectly. A refund will be provided if a bitch comes into season. Please inform the Trial Secretary as early as possible if your bitch has come into season and you would like a refund.

RETURNED CHECKS do not constitute a valid entry fee. The Dog Obedience Club of Las Cruces, Inc. will add a \$25.00 collection fee to the amount of each returned check. Subsequent returned checks from the same exhibitor may result in his or her being put on a CASH ONLY basis.

NO ENTRY FEES will be refunded if the Trial cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency, act of a public enemy, strike, or any other cause beyond the control of the Club.

A RECORDING FEE OF \$.50 will be required for each dog entered at any show held under the rules of the American Kennel Club. The AKC will also collect a \$3 Event Service Fee for the first entry of a dog and a \$3 service fee for each additional entry of the same dog in each show.

ALL ENTRIES are to be mailed with Fees to the Trial Secretary, John Dick, 304 Purple Hills Way, El Paso, TX 79912. Entries will not be accepted without fees. Acknowledgment of entries will be made as soon as practicable after the closing date. Should such acknowledgment not be received by the exhibitor within a reasonable time please contact the Trial Secretary.

DOGS MUST BE READY FOR JUDGING. The club and its committees will not be responsible for notifying exhibitors or their agents of class judging. Owners or agents alone are responsible for the presence of the dogs in the ring. Dogs need to be at the trial only at scheduled time of judging and may leave immediately thereafter unless required for further judging.

# EXIBITORS ARE ADVISED TO BRING THEIR DOG'S LICENSE TAGS AND PROOF OF RABIES VACCINATION WITH THEM TO BE IN COMPLIANCE WITH EL PASO CITY ORDINANCES.

THE CLUB RESERVES the right to restrict the number of exercise pens per exhibitor and may request that crates be stacked to maximize space available for set-ups. No roping off or reserving of crating area by any method is permitted.

ALL DOGS MUST be kept on leash when not crated or in exercise pens or in the ring.

EXHIBITORS are expected to keep crating and exercising areas clean.

ANY AND ALL DAMAGE caused by the exhibitor will be the sole responsibility of the exhibitor. Parents or guardians will be totally responsible for the actions and safety of their children.

IT IS UNDERSTOOD that the Dog Obedience Club of Las Cruces, Inc., will not be responsible for the loss of or damage to any dog from any cause, or for the damage caused by any dog. It is distinctly understood that every dog at this show is in the care, custody, and control of the handler or owner at all times. Dog Obedience Club of Las Cruces, Inc., assumes no responsibility for any damage to property or injury to children.

#### AGREEMENT

I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury, or damage to this dog.
