ORDINANCE NO. 401

AN ORDINANCE OF THE BOROUGH OF ST. LAWRENCE, BERKS COUNTY, PENNSYLVANIA, INCREASING THE BASE SEWER RENTAL CHARGE FROM \$ 30.00 TO \$ 35.00; DECREASING THE MINIMUM BASE SEWER AMOUNT FROM 2,000 GALLONS TO 1,000 GALLONS; AND INCREASING THE ADDITIONAL PER THOUSAND GALLON CHARGE FROM \$5.90 PER INCREMENT TO \$6.35.

BE IT ENACTED AND ORDAINED by the Council of the Borough of St. Lawrence, Berks County, Pennsylvania as follows:

SECTION 1. The base sewer rental charge shall be increased from its current rate of Thirty Dollars and 00/100 (\$30.00) to Thirty-Five Dollars and 00/100 (\$35.00).

SECTION 2. The minimum base sewer amount shall be decreased from the current minimum base sewer amount of two thousand gallons (2,000) to one thousand gallons (1,000).

SECTION 3. The additional per thousand gallon charge shall be increased from Five Dollars and Ninety Cents (\$ 5.90) per increment to Six Dollars and Thirty-Five Cents (\$ 6.35).

SECTION 4. Any ordinance or part of any ordinance inconsistent with the provisions of this Ordinance is hereby repealed insofar as the same affects this Ordinance.

SECTION 5. This Ordinance shall become effective on October 1, 2009.


