# Parking on the Street—NEW LAW !! Read On....



It's Not Just About Street Parking

In 2023, the Arizona State Legislature

passed HB2298, now <u>A.R.S. Section 33-1818</u>, which applies to planned communities with public roadways. A.R.S. 33-1818 only applies to planned communities that meet all of the following criteria:

- The planned community is no longer under Declarant control;
- CC&Rs were originally recorded before January 01, 2015;
- CC&Rs include on-street parking regulations; and
- The roadways within the community are public.

Because Casa del Cielo meets ALL of the criteria above, we as an HOA and planned community must have a vote of the residents for CdC HOA CC&Rs to continue regulating the public roadways in our community.

A required quorum vote, one-tenth of the votes from CdC residents, shall be met either in person at the March board meeting and/or by emailed ballot. All residents will have the opportunity to vote.

- A Vote AGAINST---will allow RVs, commercial vehicles, oversized vehicles, vehicle storage, portable bathrooms, storage pods, boat trailers, motorcycles, golf carts, etc. to be parked on the streets during the day and overnight in Casa del Cielo. Your HOA will no longer have the authority to regulate the public roadways in our community.
- A Vote FOR—will allow your HOA to have the authority to continue to regulate the public roadways in our community as outlined in the CC&Rs and Guidelines.

The Casa del Cielo board of directors strongly supports this measure and encourages you to vote FOR this measure.

If residents vote to continue the authority to regulate our public roadways, the board of directors will record in the office of the County Recorder that Casa del Cielo HOA confirms that our planned community continues to regulate the public roadways.

If the vote fails or if we do not hold a vote of residents, we will no longer have the authority to regulate the public roadways. This authority will be permanent, and we cannot change it after June 30, 2025.

WE WILL HAVE BALLOTS AT OUR MARCH MEETING FOR RESIDENTS TO VOTE. Ballots will also be emailed. Ballots can be returned via email, brought to the board meeting, dropped off at the Vogel's residence (across from the pool on San Salvador), or mailed. Instructions will be on the ballot.

#### The deadline to vote is Monday, March 24, 2025.

## Fruit Removal Policy—Deadline April 30th

A friendly reminder to please remove the citrus fruit from your tree(s) by the end of April. Fruit not picked from trees attracts roof rats and other pests if left on the tree too long.

If you need help picking the fruit from your trees or would be interested in helping to pick fruit, please let the HOA know. We have also contacted the local Boy Scout Council, and they have promised to spread the word with various local troops for a community service project. If we hear back, we'll let you know.



In addition, please deter from putting out bird seed and food scraps, which can attract rodents, coyotes, and javelinas. Thank you!
