Walls and weights are highly recommended. No electric available.

Please take a few moments to read through the following before submitting your application.

- Take care to include all of the following at time of submission; signed application, \$10 check made payable to Beth Ann Designs, 3 high-quality images of work (also to be used for promotion), 1 booth image. Email images to [hello@HandmadeHopewell.com](mailto:hello@HandmadeHopewell.com). DO NOT send images by snail mail. **Incomplete applications will not be considered.** Any vendors not accepted into the show will have their check returned by mail. Checks will not be cashed until the artist is accepted.
- In the event you are a new artisan, a booth photo can be waived with prior approval. A sketch/design layout must be submitted.
- Booth shares will be considered on a case-by-case basis. Each artist is responsible for submitting an application and paying their individual \$10.00 application fee and \$75 booth fee, upon acceptance to the show. Both artists must be accepted to the show in order to share and both artists must be present the day of the event.
- All work must be original in concept and be created by the accepted applicant. All work must be made in the USA. **Participants may only exhibit the type and quality of work shown in their supplied images.** Not accepted are items embellished or made from commercially available kits, plans, patterns, imports, factory-made or assembled items.
- Cancellation must be made in writing. No refund will be given once accepted into the show.
- Vendors are responsible for collecting 6.625% NJ Sales & Use Tax and are expected to comply with all revenue and tax laws, including obtaining any required certificates.
- Artists will be supplied with promotional materials for the event and are highly encouraged to share and promote event with their mailing list, friends, family and social media outlets.

**\*\*Event is held rain or shine. There will be no rain date. Upon acceptance to this show, artists must be prepared for any weather conditions. Artists who fail to show the day of the event will forfeit the opportunity to participate in future shows. There will be no refunds in the event promoters cancel the show due to severe weather conditions. Severe weather includes dangerously heavy wind, lightning, rain or any other weather condition that may jeopardize the safety of vendors or customers.\*\***
