Enclosed please find a copy of the 2023 Southwestern Circuit Calendar. Please check the individual published calendar for the time of court. Often the time will change from the annual calendar due to unforeseen circumstances. Please distribute copies to your various office personnel. We have included reminders as to some areas where problems often occur. Please try to address these problems in your internal office procedures.

PLEASE REVIEW THE ENTIRE MEMO

Southwestern Judicial Circuit Court Guidelines:

1. Court Reporters will be present for all regularly scheduled criminal matters. It is the responsibility of the requesting attorney to procure a Court Reporter for any civil hearing and/or trial.

2. All criminal matters are to be scheduled through the Criminal Calendar Clerk.

3. All civil matters are to be scheduled through the assigned judge's office.

4. Pursuant to Uniform Superior Court Rule 4.2 (3), please indicate your bar number on every pleading filed with the court. This is a state-wide requirement for pleadings, so please follow it. Also, the clerks' computer program identifies attorneys by bar numbers and without this number it is difficult for the clerks to prepare court notices.

5. Pursuant to Uniform Superior Court Rule 36.4 signatures on documents filed of record on all judgments, orders, pleadings and other documents shall bear the signature of the responsible attorney or party who prepared the document, with the preparer's name, proper address and telephone number typed or printed underneath

To the extent practicable, signature pages of documents filed of record including pleadings, agreements and orders shall not be set forth on a page separated from the contents of the document.

On any document filed of record, including but not limited to pleadings, agreements and orders, where a signature is set forth on a separate page from the contents of the document, the signature page must identify the parties, the case number, and the document.

6. Please include a self-addressed stamped envelope for executed orders to be returned to your office to file with the clerk. **We do not file or accept emailed proposed orders unless it is an emergency.**

7. The Court will publish calendars pursuant to Uniform Superior Court Rule 32.1. The Clerk will issue notices upon receipt of the calendar from the Court. Cases announcing ready at calendar call will be ordered to trial, and trial notices will be issued by the Clerk two weeks prior to trial. The Superior Court Judges of the Southwestern Judicial Circuit may schedule criminal or civil trials during any trial week.
8. For cases announced not ready, counsel are directed to schedule status conferences with the assigned judge to address any issues impeding resolution of the case, or be prepared to try the case at the next term. Absent providential cause, cases ordered for trial **will not** be continued.
9. If a problem arises after a case is announced ready, counsel are directed to notify the assigned judge as soon as reasonably possible, and to promptly set a status conference with the Court, prior to trial week, to address the issue.
10. It is the responsibility of counsel upon filing of any pre-trial motion to contact the Criminal Calendar Clerk to set down criminal motions for hearing. In civil motions, counsel shall contact the assigned judge's office to set down motions for hearing.

**FAILURE TO FOLLOW THESE PROCEDURES MAY RESULT IN DISMISSAL OF THE CASE**

The Court reserves the right to modify or adjust the provisions in the interest of justice on a case-by-case basis at the discretion of the **assigned** judge.




