I am also appointing Tim Hart and Chester Rawski to the by-laws committee along with the members assigned in the by-laws, and guidance from Dale Mallicote. I'm asking them to start, as soon as practicable, reviewing and revising the 2014 by-laws and bring them up to date with the current wishes of the post membership.
