DAHA suggests that you sign up to work or pay sponsorship prior to the first show. This will benefit sponsors greatly as we will have time to get them in the show booklet and flyer.**

### 2020 Registered Point System Rules

1. Shows to count are Keystone, SBRAA, Delaware (must show for any points to count), GEAR, GSAA . See Rule 10
2. Horse enrolled must be registered with ApHC
3. All owners must be current paid DAHA members
4. **NO POINTS will count until all membership requirements have been met. This includes proper enrollment fees and papers.**
5. There is a \$20.00 fee for each horse enrolled. All Non-Pros have a \$20.00 fee plus the \$20.00 horse fee. All Youth have a \$20.00 fee plus the \$20.00 horse fee. Youth eligibility of age is determined by January 1<sup>st</sup>, regardless of the actual month of birth.
6. **A Xerox copy (front & back) of horse's papers must be submitted to the Treasurer at the time of enrollment. The completed form, fees and copy of papers must be postmarked before the show date you wish to count for points.**
7. In the event that an exhibitor is in the process of transferring a horse and wishes to enroll in the point system, a Xerox copy of the transfer must be submitted to the Point Keeper. When the original papers come back, you must send a copy to the Point Keeper by September 1<sup>st</sup>.
8. In the event that any questions may arise with regard of the horse's ownership or registration, the original registration must be presented to the Board of Directors who will in turn make the final decision.
9. At the time that the final point standings are published, a deadline for reporting any questions concerning the point standings will be published. After this date the standings will be final.
10. All points from approved shows must be turned into the point keeper within 20 days of the show. They must be post marked no later than 20 days from the show date and if not received will not count. Points will be posted as final 30 days after the approved show.
11. You must notify the point keeper by January 1<sup>st</sup> to make arrangements on how your awards will be picked up or they will become property of DAHA
12. In order to qualify for a year end award in any division, the enrolled must have shown in at least 4 DAHA shows(Fall Spotacular) in the class that you want your awards to count towards divisions and worked 7 hours at the DAHA shows per exhibitor(IE:DAHA Member). A member may have someone volunteer to do work hours, but must sign in and designate who they are working for. In lieu of working 7 hours, you can pay a buy-out or get \$250 in sponsorship's for registered point nomination. Exhibitors also must have 2 points per enrolled class for that class to count toward over all point standings. The only exception to the 2 point per class rule will be the weanling, 2 year old (HUS & Snaffle Bit) and longe line horses, who must show the September show. DAHA suggests that you sign up to work or pay sponsorship prior to the first show. This will benefit sponsors greatly as we will have time to get them in the show booklet and flier. (It is the members responsibility to check in and make sure that time worked is recorded) In the event of injury to exhibitor or horse, member may present a medical note to ask for exception from the DAHA show. This does not guarantee the board will waive the mandatory show rule. Things that will be considered, fund raising, participation in other events
13. **Must show two classes per division with one being a performance class to be eligible for over all points. (Non-Pro & Youth Walk Trot divisions showmanship age division & Halter will count. In the event that a Non-Pro shows in more than one showmanship class (NP, 35 & Over or Masters), the class with the most points will be counted**
14. Grand and Reserves count as follows 10 points for grand and 5 points for reserve.
15. All DAHA shows will count for double points
16. The system for accumulating points will be awarded to the first 8 placings in a class. For example a class with 8 or more horses 1<sup>st</sup> – 8pts, 2<sup>nd</sup> – 7pts, 3<sup>rd</sup> – 6pts, 4<sup>th</sup> -5pts, 5<sup>th</sup> – 4pts. 6<sup>th</sup> -3pts, 7<sup>th</sup> -2pts, 8<sup>th</sup> – 1pt. If there are not 8 or more entries, then the points will count down with 1<sup>st</sup> place receiving total number of entries in the class. The National show will accumulate for the top 10 horses.
17. **Any of the above rules are subject to change.** (in the event that ApHC, the fairgrounds, or any other contractor/vendor we have a contract with changes their rules).
18. **All current year rules supersedes all prior year rules**

### 2020 Eastern Shore Western Horse Show Association/Open Point Rules

1. The only shows to count are ESWHSA. You must show in the division that you want your points to count and work at least 5 hours per exhibitor (IE: DAHA Member) at the DAHA sponsored show or DAHA registered show. In lieu of working 5 hours you can pay a buy-out or get \$200.00 in sponsorship's for open point nomination. A member may have someone volunteer to do work hours, but must sign in and designate who they are working for. **DAHA suggests that you sign up to work or pay sponsorship prior to the first show. This will benefit sponsors greatly as we will have time to get them in the show booklet and flier. (It is the members responsibility to check in and make sure that time worked is recorded)**
2. You must show at the DAHA sponsored show in order for points to count. Exhibitors must have at least 8 points per division to qualify for year end awards. You must show 4 of the 6 show dates. The only exception to this rule is for **Yearlings and Weanlings which will only need a minimum of five (5) points. Exhibitors must show in 2 classes per division to be eligible for over all division.**
3. All horses must be enrolled for points to count. If registered a copy of the papers are to be turned in with nomination form
4. **All owners, youth and adults listed for points must be paid DAHA members. No points will count until all requirements are met with completed forms.**
5. There is a \$20.00 fee for open classes per horse. This will cover, Halter, Western Performance, Western Horse Under English Tack (includes English Equitation).
6. Youth eligibility of age is determined by January 1<sup>st</sup>, regardless of the actual month of birth. The fee for enrolling is \$20.00 for the youth and \$20.00 for the horse. Points will be tabulated on the youth and their age division.
7. The Adult division points will count for adult classes only. They are Showmanship, Horsemanship, Pleasure, Trail and Walk/Jog. The fee for enrolling in the adult division is \$20.00 for the adult and \$20.00 for the horse.
8. As the final point standings are published, a deadline date of November 1<sup>st</sup> will stand for reporting any questions or concerns. After this date the points are final.
9. In the event of a protest over papers, age, eligibility, the issue will be presented to the Board of Directors. At that time you will be required to show proof of what ever charge. The board will make the final decision.
10. Points will count as follows: Number of horses in class up to 6 horses (1 horse = 1 point). 6 or more horses – 1<sup>st</sup> = 6 points, 2<sup>nd</sup> = 5 points, 3<sup>rd</sup> = 4 points, 4<sup>th</sup> = 3 points, 5<sup>th</sup> = 2 points and 6<sup>th</sup> = 1 point, with the exception of the DAHA show which will be doubled.
11. Awards will be given in the following divisions for registered Appaloosas that are currently enrolled with DAHA:

Halter Weanlings (all sexes)	Leadline – 6 and under
Halter Yearlings (all sexes)	Youth – 9 and under
Halter Stallions	Youth – 10 to 13
Halter Mares	Youth – 14 to 18
Halter Geldings	(Age groups will include all classes specified to that age group)
Yearling Longe Line	2 & 3 YO Snaffle Bit
Western Performance	Western Horse Under English Tack- (includes English Equitation, Hunter In Hand)
(all open non age specific classes)	Limited Adult
Adult – 19 and over	Limited Youth

## Delaware Appaloosa Horse Association 2020 Show Rules

1. All owners and exhibitors must show their **current ApHC card in order to show**. If you don't have one, you will have to purchase one at the show.
2. Registration papers and proof of coggins with in one year are required.
3. Rules: ApHC current year edition of the official ApHC 2020 handbook.
4. Any returned checks will be charged a \$75.00 fee.
5. All horses staying the night must be stalled in the fairgrounds stalls. Horses are not to be tied or left in trailers overnight.
6. Anyone using an extension cord running from the barn to their dressing room, tent, trailer, ECT. Will be charged for a campsite. Camper passes are available at the show office and must be displayed. Failure to display will warrant disconnecting your power.
7. DAHA and the Delaware Fairgrounds will not be held responsible for any injuries or losses that occur to horses, riders, spectators or vehicles.
8. **WARNING:** Under Delaware law – An equine professional is NOT liable for an injury to or the death of a participant in equine activities resulting from the inherent risk of equine activities, pursuant to 10 Delaware Code Section 8140.
9. Pets are to be restrained on leashes at all times. **No Dogs Are Allowed In The Quillen Arena.**
10. For your child's safety, please maintain some restraint.
11. **Absolutely no refunds will be made without a veterinary certificate prior to or without visible cause as determined by the show committee. Absolutely no refunds on scratched classes.**
12. We reserve the right to blood test for drug detection.
13. No motorized scooters or mopeds are allowed in the Quillen Arena. Bicycles are not to be ridden around the arena or in the barns. **No Grilling** in or around barns.
14. High points will be given in the following categories: Halter Mare, Halter Gelding, Halter Stallion, English Horse, Western Horse, Over All Horse, Games Horse, Non-Pro, Novice Non-Pro, Non-Pro 35 & Over, Non-Pro Walk/Trot, Non-Pro Masters, Novice Youth, Youth 13 & Under, Youth 14-18, Walk/Trot 10 & Under and Walk/Trot 11-18. High points for youth and non-pro will count on the exhibitor and not the horse.
15. There will be no class fee for lead-line. The \$4.00 ApHC fee and office fees still apply.
16. Fees:  
Individual Class Fees:  
\$15.00 office charge per horse  
Entry Fees: \$40.00 per class. Plus \$8.00 ApHC fee per class for open classes. Plus \$4.00 ApHC fee for Non-Pro and Youth classes.  
Or  
Weekend Fee Options:  
  
\$165.00 blanket fee plus ApHC fees (\$8 ApHC fee for open classes. Plus \$4.00 ApHC fee for non-pro and youth classes. Must show in one open class to qualify for blanket fee.  
  
1 horse/3 riders or 3 horses/1 rider (includes all classes – open, youth and non-pro)
17. In the event of an act of God (IE: tornado, hurricane, earthquake) and DAHA **CAN NOT** hold a show. There will be **NO REFUNDS**
18. All prices are subject to change. Any of the above rules are subject to change.

**2020 Work Hours Guidelines**

1. It is the members responsibility to make sure that all hours are entered into the Log Book. The Log Book will be available at every event
2. If a member chooses they can pay a Buy Out in Lieu of working
3. A member may have someone volunteer to do work hours. The volunteer must be noted in Log Book
4. Work Hours or Buy Out **MUST BE** Completed by the end of the September Horse show in order to be eligible for year end awards
5. All Task must be signed off on by a DAHA Board Member. If there is no signature by BOD, the time will not count.
6. We offer plenty of oportunities to get work hours. Setting up/breaking down for banquet, setting up/tearing down for tack swap, open horse show, September show, and various fundraisers that include Greenwood Chicken BBQ
7. Members will be rewarded with 15 minutes of work time for every item donated to DAHA . Member must check item in with BOD to get time rewarded.
8. At the Open & September shows there are plenty of task to help get work hours completed. Such as setting up/tearing down, awards table, setting up/tearing down pattern classes, gate, coping cards. We will try to keep a list of task that need to be done at the shows, but we suggest that you contact a BOD to get an assignment of what task need attention at the times you are available.
9. If a BOD is not available or there is a question on what task need to be done contact Tammy 302-526-6944 and she will assign a task to you.
10. Required hours needed
  - A. Registered Point System – Work 7 hours or pay \$250.00 Buy Out
  - B. Open Point System – Work 5 hours or pay \$200.00 Buy Out
