# SWFL Five Forks Foodies Review

Buckingham Farms is a quaint “Old Florida-Style” restaurant located about 30 minutes north of Eagle Ridge. They offer home cooked breakfast items like avocado and egg biscuits, eggs Benedict, biscuits and gravy. Lunch menu consists of crab cake BLT, Cuban sandwiches, pork tacos, short rib brisket-blend ground beef burgers. Definitely try the barnyard chicken sandwich. It is a boneless grilled chicken breast in a bourbon molasses glaze, topped with bacon, smoked Gouda



cheese on a grilled brioche bun. They also have weekly Friday night take-out specials that can be picked up on Friday from 5 to 6 p.m. All of their menu items can be ordered on their website: [buckinghamfarmsonline.com](http://buckinghamfarmsonline.com).

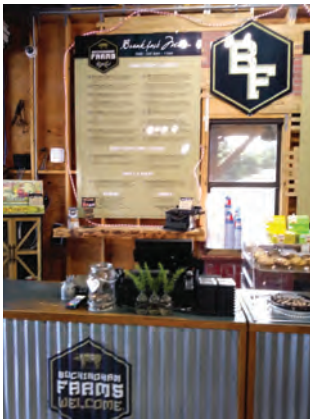
Not only is Buckingham Farms one of the best kept secrets for restaurants in Fort Myers, they also have a huge farmers’ market where you can purchase fresh produce, local honey, grass fed beef and bison, chutneys and spreads, homemade desserts, and farm-fresh eggs.

They are located at 12931 Orange River Blvd., and

are open Tuesday through Saturday from 8 a.m. to 3 p.m. and Friday, 5 to 6 p.m.

A second Buckingham Farms location is set to open this month. It is located off of State Road 80 near Shady Oaks Avenue in LaBelle. They have partnered with LaBelle Brewing Company. This second Buckingham Farms restaurant will offer lunch and dinner, with the possibility of adding breakfast over time. Its menu will be largely the same as the original Buckingham Farms. And, like the original, the LaBelle restaurant will source as much produce as possible from the farm’s 50-acre Lee County spread.

Buckingham Farm’s produce will also go into LaBelle Brewing’s craft beers.

The month of October is Halloween and all the fun it brings. It is also known for National Breast Cancer Awareness Month, National Book Month, and Country Music Month. On the food end, the month is known for Pear and Pineapple Month, Rhubarb Month, National Pork Month, and close to my heart is National Cookbook Month. I have written two cookbooks and am working on the third. The one I will use today for October is Spinach Lovers’ Month. I make this really great Spinach Souffle. Give it a try. Enjoy!

**Spinach Souffle**

- 1 package frozen chopped spinach, defrosted and drained
- 1 can cream of mushroom soup (not diluted)
- ½ cup butter or margarine, melted
- 1 egg
- 1 cup croutons (They can be plain or herbed.)
- 1 ounce grated mozzarella cheese

Mix all ingredients together. Put in a casserole dish. Bake at 350 degrees for 50 minutes. Serves 4 to 6 people. Can be served with pork chops, ham, chicken or steak.

Last August a tree by our back window on Soaring Eagle was stuck by lightening. The explosion was tremendous, and we ran out of the house to see what happened.

The yard was being showered with debris and we could smell fire. We found some of the palms next to the tree that were burning. While my husband tended to the fire, my daughter and I found an adult male osprey upside down



with its head tucked under its back. We realized it was in the tree that had been struck.

My daughter turned the bird over and picked it up. It actually seemed to appreciate being held. We brought it to Blue Pearl Pet Hospital on Daniels Parkway, who in turn sent it to Clinic for the Rehabilitation of Wildlife (CROW) on Sanibel. To our delight, the osprey was fine – just stunned, and 72 hours later a volunteer from CROW brought the osprey back to release it in the yard.

## Lee County Yard Waste Regulations

- **Do not place out for pickup more than 24 hours early.**
- **Yard waste must be containerized (50 pounds or less), or securely tied into bundles not heavier than 50 pounds and no longer than 6 feet in length.**
- **Up to 50 pounds of unbundled palm fronds may be placed at the curb. Any excess palm fronds must be tied into bundles, each weighing 50 pounds or less.**
- **When using plastic bags, make sure that the contents can be easily identified by the refuse truck driver (leave a twig or small branch sticking out).**
- **Call 239-337-0800 for a cost estimate for large-scale yard waste disposal projects when containerizing or bundling is difficult.**

It is at the end of Eagles Flight at Bald Eagle and you would turn left, which is not in our community. A car was broken into and several items were stolen. Again, I say, and the sheriff’s office says, “Lock it or lose it.”



We also had a truck damage the island at the corner of Daniels Parkway and Eagle Ridge Drive. We are in the process of claiming the damages through the driver’s insurance company.

School is in session. Remember to stop for school buses when the lights are blinking. Watch out for children walking to the bus stop in the early morning hours as well as all day. Remember the speed limit within our community is 25 mph. The streets are narrow and there are walkers, joggers, dog walkers and children. **Slow down.**

I have met with my new staff officer in the sheriff’s office. He will be helping me and driving through the community

checking on speeders. He will also drive through in the later hours to check for trouble. Remember, if you see something that is suspicious call the sheriff’s office. If you feel it is not an emergency call the nonemergency number at (239) 477-1000. If you are unsure and feel it could be a threat to someone or the community call 911. It is better to have the sheriff’s office send out a squad car to check things out than have a problem occur.

One of the things the staff office let me know is that people who have a Ring doorbell that contains a video may be asked to have the officer view the results if there is a disturbance in the area. This is very helpful and can be used to protect the community. We are going to put a Ring doorbell with video in our house. I think it could be helpful if we know who and how many Ring doorbells we have in our community. If you have a Ring doorbell and one with a video, please let me know and I’ll make a list of them in our community. It will be confidential. The sheriff’s office looks at houses when there is an incident in the area to see who has one and if they could check out the video for proof of identity. Here are some facts from the Florida Fish and Wildlife Conservation Commission:

Coyotes can and do prey on domestic cats and small dogs. Most coyote attacks with pets occur either at night or in the early evening or morning hours (dusk and dawn). To protect your pets, do not allow them to roam freely. Keep cats indoors. Free-roaming cats are at a high risk of being preyed on by coyotes and other animals. Walk small dogs on a short leash that is less than 6 feet, especially at night, dusk or dawn. Be extra careful if you are going to walk your pet in wooded areas or areas that have heavy foliage, where coyotes may rest.

Condos v. ERPOA litigation: We await a decision from the Second District Court of Appeal on a motion for rehearing filed by the condos after the appellate court ruled in favor of ERPOA on July 10, 2019.

With the assistance of resident Jim Lutsch, the storm water drainpipe replacement work at Eagle Ridge condominiums was completed. The contractor was the Bonness Company from Naples. Bonness actually replaced more linear footage than originally estimated but did not charge more than the estimate. Bonness was very professional and once the work began it was completed promptly.

Jim Lutsch was very helpful in overseeing the work, thank you, Jim.

**Utilities Inc., Variance Application**

This information is repeated and was discussed at the March 21 and May 6 Board meetings. Hewitt McCloskey will report on this matter.

**Vice President’s Report: Christine Leslie**

We may need to have an engineer examine the flow way from Eagles Flight to Twin Eagle, depending on how the rainy season progresses. Also, may need to look at Majestic Eagle pipe.

**Director’s Report: Hewitt McCloskey, Jr.**

1. Prepare for, attend and speak at the Lee County zoning variance meeting. We, ERPOA attempted to block the Utilities Inc. of Florida request to allow construction in the building set-back line. The meeting was attended by Christine Leslie and Ed Schuler.

2. We now have a new landscape maintenance contractor, Benjamin Simon Lawn Maintenance. He has been in place as of Aug. 1 at a cost saving to Eagle Ridge of approximately \$7,500. So far, he is doing an excellent job.

3. We are in the process of repairing the property damage caused by a DUI driver on Aug. 25. It will be an insurance claim against his insurance company. I have met with Benjamin Simon and I am directing the details of the repairs.
