The bidding will be conducted through Public Bidding pursuant to Republic Act (RA) 12009, otherwise known as the "Government Procurement Reform Act". The bidder shall complete the supply of labor and materials for one hundred twenty (120) calendar days upon receipt of Notice to Proceed and conformance to the Purchase Order (PO).
