

**Town of Stratton  
Selectmen's Meeting  
March 13, 2023**

**Present:** Selectmen: Al Dupell, chair, Chris Liller, and Greg Marcucci; and Kent Young – Clerk.

7:30pm: Al Dupell called the meeting to order. Orders were reviewed and signed.

**Modifications** – No modifications were made.

**Mowing Bids:** Mowing bids were submitted only by Re-Pete Property Maintenance Services. The following bids were submitted:

- 1) The area surrounding the Town Office, Town Hall, Meetinghouse and Schoolhouse - \$100.00 per mowing with spring and fall clean up of \$55.00 / hr. and, if necessary, use of the mini-excavator at \$125.00 / hr.
- 2) Rec. Area \$285.00 per mowing with the same clean up rates and mini-excavator rate as above.
- 3) Daniel Webster Monument area - \$95.00 per mowing with the same clean up rates and mini-excavator rate as above.

Greg Marcucci moved to approve. Chris Liller seconded – all concurred.

**Road Crew Issues: FLEET Permits:** The Board agreed to approve permits for: 1) Consolidated Communications and 2) rkMiles. Al Dupell signed the permits.

**Road Naming:** The Selectmen reviewed a letter submitted by Drew Glennon to name a private road into a subdivided property he owns and shares a right-of-way with 347 Stratton-Arlington Rd.. He requested to name said private road – Oakmont Ln. Chris Liller so moved. Greg Marcucci seconded – all concurred.

**Annual Appointments:** The following appointments were considered:

- 1) Beth Liller and Gerry Cloutier as back up Transfer Station attendant (as needed).
- 2) Zoning Board of Adjustment member for a three-year term – Paul Bernard
- 3) Tree Warden (one-year term) – Al Dupell
- 4) WSWMD Rep. (one-year term) – Kent Young
- 5) Windham Regional Commissioners (one-year term) – Renee Mulkey and Erica Reynolds
- 6) No volunteers were found to fill the Emergency Management Coordinator.

Greg Marcucci so moved to approve all said appointments given above. Chris Liller seconded – all concurred. The Clerk stated that the Planning Commission will convene this spring to recommend the Zoning Administrator and Assistant to the Zoning Administrator positions for those three-year terms due this year. He said that the VT Dept. of Health will also request an appointment for Health Officer.

**Town Hall Rec. Area:** The Selectmen considered a request from Virginia Pearson to use the Rec. Area Ball Field for an anniversary party, with tent on August 26, 2023. Chris Liller so moved. Greg Marcucci seconded – all concurred.

**Minutes of Town Meeting:** The board reviewed, approved and all present signed the Annual Town Meeting Minutes of March 7, 2023.

**Minutes:** Greg Marcucci moved to approve the Selectmen's minutes of February 27, 2023 and the Organizational Meeting minutes of March 7, 2023. Chris Liller seconded – all concurred.
