Full participation and cooperation with the Trainer(s) is required during Training Sessions / Classes. All training results are contingent upon the Client following the directions of the Trainer(s) and their willingness to handle / work with their dog(s).

The Client may have their pet withdrawn from training at any time, however, once training has begun; all fees for training are non-refundable.

Cancellation notification for Private Training Sessions must be given at least twenty-four (24) hours prior to any scheduled training session to avoid full session charges. Notice of cancellation must be made (by phone or in person) at Ranger's Pet Outpost and Retreat® (407) 622-4884.

The Client is responsible for purchasing all necessary training supplies / equipment that is required for training.

LIABILITY WAIVER

I _____ (the Client) as the Legal Owner/Agent of the abovementioned Pet(s), have carefully read and fully understand this agreement, do hereby waive and release the Company and its Agent / Trainers / Instructors / Staff from any and all liability of any nature.

I understand that attendance of Dog Training Class / Session is not without risk to myself, members of my family, guests who may attend, or to my dog.

I fully understand the risks entered into and take with full responsibility for my dog's behavior at all times.

This Liability Waiver includes any injury, death, sickness or damage my pet may suffer during or after any participation in training / instruction.

I agree to indemnify and hold harmless the Company and its Agents / Trainers / Instructor / Staff from any and all claims due to damage my pet may cause to any family members, any third parties or other Clients / Training Participant during or after training.

I hereby indemnify and hold harmless the Company and its Agents / Trainers / Instructors / Staff of any and all claims, or claims by any member of my family, or accompanying guest of mine of injury, expense, costs or damages to myself, my dog or any handler sponsored by me both in and out of any training class or session.

I have read hereby agree to abide by the rules and policies of the Company and the policies in this Training Service Agreement and Ranger's Pet Outpost and Retreat® Service Agreement.

In addition, I agree that I will defend and indemnify the Company for any injury, expense, costs or damages to any dog handlers or dogs, whether sponsored by me or not, or to third parties arising out of my own actions or the actions of my dog(s).

The Training Service Agreement represents the full agreement between the parties. The terms and conditions set forth in this Agreement cannot be modified or changed in any way unless agreed to by both parties in writing. I have read, fully understand and agree to all the terms of this Training Service Agreement.

I (the Client) hereby release and agree to hold the Company its Owner's, Employees, Associates, Trainers / Instructors and Agents harmless from any and all manner of damages, claims, losses, liabilities, costs or expenses, causes of action or suits, whatsoever in law or equity (including without limitation, attorney's fees and related costs) arising out of or related to any services provided by the Company, its Owners, Employees, Associates, Trainers / Instructors and Agents.
