4) Approval of Minutes: (Freeman)

- Minutes of the July 24, 2019 General Membership Meeting were approved without alteration.

5) Membership Report: (Sessa)

- To date, the Post reached 64% of our renewal goal for the 2019-2020 FY.

6) Finance Report: (Pratt)

- Doug Pratt reported the 2019-2020 annual budget was approved at the July monthly meeting. The month of July totals reflected membership dues and one donation for Boys State. The major deposit from Military Appreciation Day had not yet been provided as of this report.
- Month of July reflected minor expenditures. The primary expenditure going in the form of membership fees paid to the American Legion, Department of North Carolina.
- The Finance Report was approved without alteration.

7) Service Officer Report: (Muir)

- Steve Muir reported that he and Gary Crowden met with the Secretary of Veteran Affairs Robert Wilkie and Senator Thom Tillis concerning the availability of health care for local area veterans.
- Eastern North Carolina clinics are running at over-capacity with veterans coming to the Wilmington clinic from other areas to be treated.
- The VA has promised more medical staffing for the Supply, NC clinic.
- Mission Act: Urgent Care locations will be coming online in the near future. More info to come.
- Veterans Experience Action Center (VEAC) Sept 12-14, 2019 in Cary, NC. Vets meet with VA reps to review and make compensation decisions for their case. Some vets had been waiting 3-7 years for a decision.
- Helped with burial benefits and a marker for a Korean War veteran on Oak Island.
- Reopened claim for a Viet Nam veteran who was awarded the DFC.
- Helped Viet Nam veteran who fell behind on his medical co-payments. 3 Legion posts in the area donated funds to help cover the shortfall.

- Mark discussed the positives and pitfalls of estate planning, wills, healthcare power of attorney, planning for incapacity, and tax issues that arise when someone dies.
