### EXPOSED TREE ROOTS AND METAL EDGING



The majority of the exposed tree roots that posed a possible safety hazard have been removed from all 3 lake walking trails. Next item to be done is the removal of exposed metal edging on all 3 lake trails that could also be a safety hazard to residents. Then additional granite gravel will be added to muddy areas or low spots where water tends to puddle.



### SECTION #4 SINK-HOLE

The section #4 sink-hole on property owned by Windfern Forest Utility District will soon be repaired and the area re-landscaped. After many months of discussion with Windfern Forest Utility District they have agreed to pay for ½ the cost of repairing the sinkhole. The Woodwind Lakes HOA is very pleased to see this project move forward for the safety of our residents and the beautification of our community.
