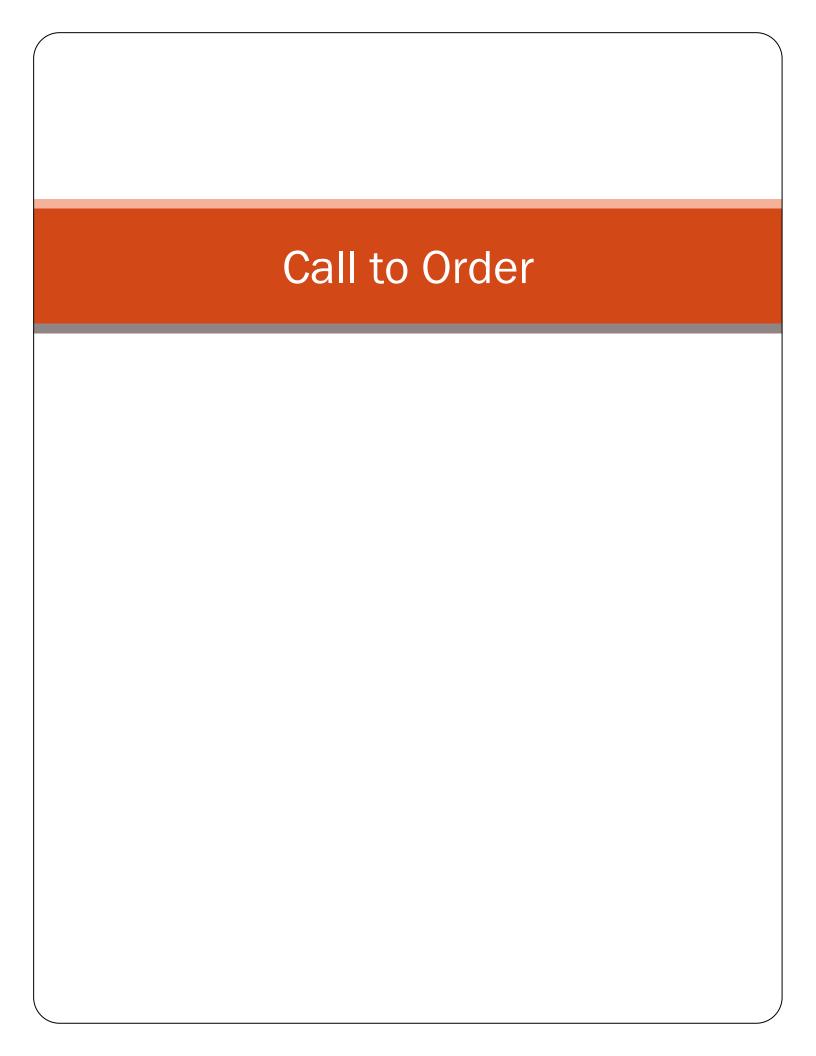

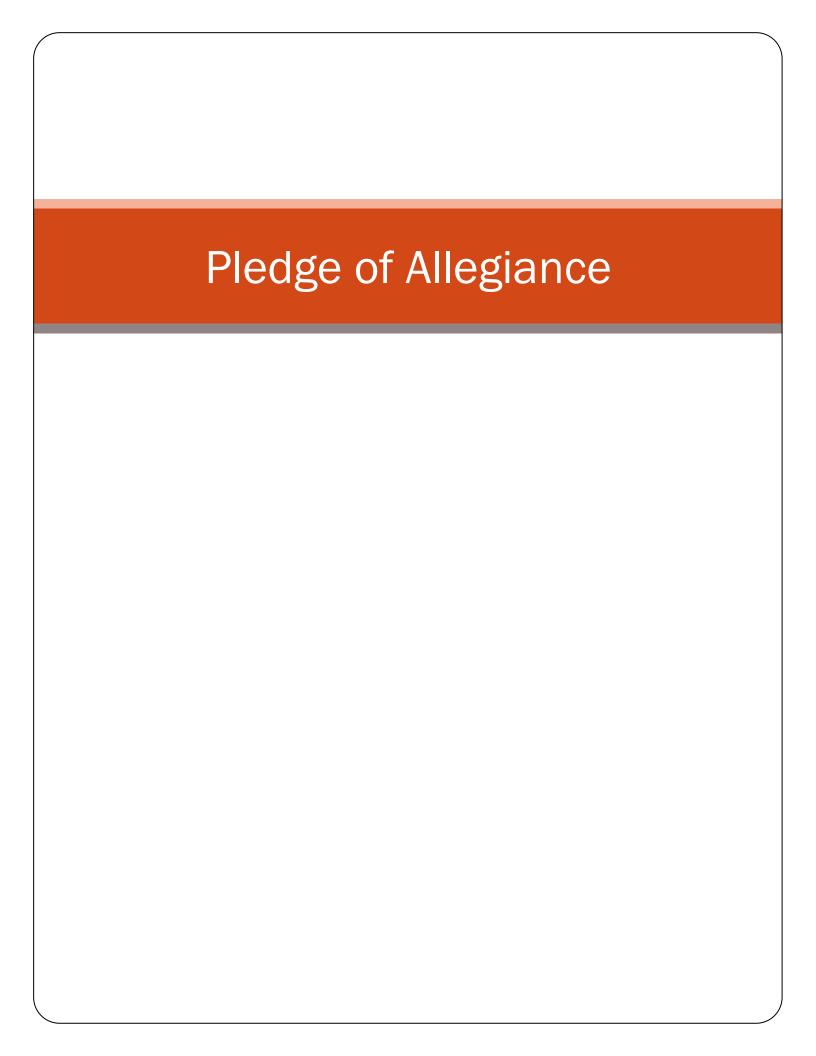

Acceptance of Lyons Elementary School District 103 **Amended Resolution**

AMENDED RESOLUTION APPOINTING MEMBER TO SERVE AS THE TOWNSHIP OF SCHOOLS TRUSTEE FOR SCHOOL DISTRICT 103

WHEREAS under Article 10, Section 20.5 of the Illinois School Code, the Board of Education (the "School Board") of School District 103 (the "School District") has the power to adopt and enforce all necessary rules for management and governance of the public schools of their district; and

WHEREAS, the General Assembly recently passed Public Act 103-0790 which requires certain school boards to appoint one member of the school board or one school employee to serve as a trustee of schools of the township; and

WHEREAS, the appointment of such individual shall not serve longer than 2 years unless reappointed by the school board to renew; and

WHEREAS, The School District on September 24, 2024, appointed Sara Andreas; and

WHEREAS, Sara Andreas is no longer able to serve as the Township Schools Trustee for School District 103 due to other obligations; and

WHEREAS, the School District declares a vacancy in that seat and now seeks to appoint William Channell to serve as the Township Schools Trustee Member for School District 103 for the remainder of the two-year term.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Education of School District 103, Cook County, Illinois as follows:

Section 1: That all recitals and legislative findings contained in the preambles to this Resolution are true and correct and are hereby incorporated into this Resolution as if fully set forth herein.

Section 2: The School Board approves to appoint Assistant Business Manager, William Channell to serve as the trustee for the Township Trustee of Schools on behalf of School District 103 for the remainder of the two-year term. This person is expected to attend all meetings of the Township Trustee of Schools.

<u>Section 3:</u> If any section, paragraph, clause, or provision of this Resolution shall be held invalid, the invalidity thereof shall not affect any other provision of this Resolution.

<u>Section 4:</u> All resolutions, motions, or orders in conflict with this Resolution are hereby repealed to the extent of such conflict.

Section 5: This Resolution shall be in full force and effect from and after its passage provided by law.




