ELIGIBILITY & ENTRY DETAILS

- Current LWAA members and Laguna Woods Village residents, valid email and telephone required.
- Original art only (no copies of other artwork, giclées), signed, and properly wired for hanging. Artwork will hang for one year.
- \$25 per artist entry fee covers 1–2 works. **Checks only** made payable to Laguna Woods Art Association.
- Submit entry form(s) with check (No Cash). GRF Hold Harmless Form must be signed and submitted with entry form. Entries will not be accepted without this form. Drop-off entries at **Clubhouse 4 Art Studio** (envelope marked *CCE Entries – Diane Corbin*).

IMPORTANT DATES

- **Registration Deadline:** Tue. **Dec. 9, 2025 at 6:00 PM. NO changes or entries accepted past this date** Entry forms available in Clubhouse 4 Art Studio and on website.
- **Artwork Delivery:** Tue. **Jan. 6, 2026** (time slot assigned). Check in at the LWAA table across from the elevators at the Community Center. All entries must have ID slips affixed to back of artwork prior to arrival. Substitutions of artwork are not allowed.
- **Non-selected Pickup:** Sat. **Jan. 10, 2026, 12–2 PM.** Artists will be notified by email or text of any non-selected artwork.
- **Public Favorite Voting:** Feb. 1 – Mar. 1, 2026
- **Artists Reception:** **TBA** (award winners & public vote announced)
- **Exhibition Ends / Pickup:** Mon. **Jan. 4, 2027** Time to be announced. The Community Center, GRF & LWAA are not responsible for any artwork not picked up. Arrangement for pick-up of artworks is the artists' responsibility.

ARTWORK REQUIREMENTS

- **Size:** Min. 11"x14", Max. 48" h x 60" w (frame included).
 - **Framing:** Suitable for professional gallery hanging. Gallery-wrapped canvas 1" or more are accepted unframed. Canvases unframed & under 1" depth subject to jury approval
 - **Criteria:** Artwork must be dry. Frames are properly wired for hanging (no saw teeth hangers), clean of dust and debris under any glassed paintings, and clear of all scratches or dents.
- **Mediums:** All 2D and mediums are acceptable. **No photography or digital art.** **Preferred:** landscapes, abstracts, still life, figurative.

JURY & JUDGING

- **Juried Exhibition:** LWAA Board and Office General Management input. This is a juried exhibition and not all artwork submitted will be selected.
- **Judges:** Art Professionals not living in LWV. Judging criteria based on concept, composition, use of media, and presentation.
- **Awards:** Best of Show, 1st, 2nd, 3rd, and Honorable Mention. Winners will be announced at artists reception.

INSURANCE

- In case fire, theft, or damage by one of GRF's employees, the maximum insurance from GRF is \$500. Laguna Woods Art Association (LWAA) assumes no liability. GRF insurance has a \$10,000 deductible and therefore GRF is not providing insurance for loss of or damage to the art work. However, if loss or damage does occur to one or more pieces listed, due to the negligence of GRF or it's managing agent, a claim may be submitted to the insurance department. In any event, GRF's liability will not exceed \$500 per item regardless of the estimated value provided.

SALES & REPLACEMENTS

- Sales of artwork are artist's and buyer's responsibility. Artwork sold from February 1 to May 1 may not be removed before May 1, 2026. **Advise buyer accordingly.** Replacements must match size and theme.
- No artwork is to be removed and replaced without prior authorization of the show's Chairperson Diane Corbin and the Community Center Curator Ellyce Rothrock. Wall cards may not be removed or altered. Wall cards will be replaced by LWAA.
- Unauthorized removal or location changes of art will result in dismissal from current and all future CCE exhibits.
