### Trump Administration Formally Ends Biden-Era War on Gun Dealers

On April 7, the Trump Administration formally revoked the Biden-Harris Administration's "zero tolerance" policy for inspections of federal firearm licensees (FFLs).

The edict ended a bureaucratic reign of terror that was costing small business people their livelihoods over harmless clerical errors in the voluminous paperwork that accompanies regulated gun sales. Also announced were a review of two anti-gun administrative rules from the prior administration, one on the status of braced pistols under the NFA and another on who is required to become an FFL to sell guns. These moves continue the rollback of anti-gun policies perpetrated under Biden-Harris and signal a significant, pro-gun shift by the Trump Administration.

This presumably means ATF will return to its prior practice of conducting inspections in a more holistic manner that considers the facts and circumstances of each case and allows for remedial measures to be taken where the FFL was operating in good faith.

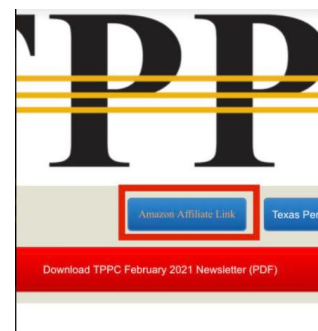
The April 7 announcement also noted that DOJ and ATF have plans to revisit the regulatory framework surrounding stabilizing braces (Final Rule 2021R-08F) and the definition of "engaged in the business" of firearms dealing (Final Rule 2022R-17F).

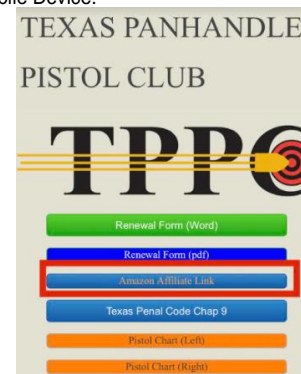

[Texas Lawmakers Advance 'Kyle's Law' to Strengthen Self-Defense Protections for Gun Owners](#)

Texas House Bill 170, also known as "Kyle's Law," amends existing Texas law to provide comprehensive civil immunity for individuals who are cleared of criminal charges after using force or threats of force in self-defense. Under the bill, Texans who are not indicted by a grand jury, have charges dismissed or are acquitted at trial would be shielded from civil liability arising from their actions.

This immunity extends not only to the use of force but also to threats of force deemed justified under Chapter 9 of the Texas Penal Code, which outlines self-defense protections. Defendants who prevail in civil lawsuits filed against them after being cleared criminally may also recoup attorney's fees, court costs, lost income, and other litigation-related expenses. This measure aims to deter politically motivated or frivolous lawsuits designed to bankrupt individuals who lawfully defend themselves.

[It's Glover: Glock to Discontinue Dozens of Legacy Models](#)

Word is circulating far and wide that a ton of Glock models, some that have been around for decades, could be headed for that great big polymer pasture in the sky.

Sifting through the tea leaves, most models appear to be guns in arcane or aging calibers such as .357 SIG, .40 S&W (even in Gen 5 models), and .45 GAP. Also gone are the company's few remaining production Gen 3s and most of the Gen 4s, anything with upgraded sights such as Ameriglo Bolds or Glock Night Sights, and the new G49. This heavily impacts guns that were grandfathered on California's approved handgun roster, which sucks for folks out there.

Keep in mind that none of this should be that shocking, as the G49 was billed from the beginning as a limited run. Glock was really the only company trying to make the .45 GAP happen, and many handgun makers have long ago stepped away from .357 SIG and .40 S&W. Case in point: SIG has not produced pistols in those latter two calibers for several years. Plus, it is common for gunmakers to clean up their catalogs and discontinue certain configurations wholesale, something that Glock hasn't done in a long time.
