I agree to comply with any and all directions, guidelines, schedules and rules which may be set forth prior to or during the festival, and to hold harmless Tucson Pride, from any and all liability for injury and damage that may occur during the Pride in the Desert festival.

I agree to maintain at all times while performing under this agreement:

Comprehensive General Liability (CGL) or Public Liability insurance, with limits of liability not less than:

- > Bodily Injury - \$1,000,000 each person per occurrence/aggregate
- > Property Damage - \$1,000,000 per occurrence/aggregate limits

I also agree to provide Tucson Pride with a certificate of insurance for the aforementioned amounts, naming both Tucson Pride and Pima County as additionally insured. Such insurance shall be primary insurance to any other valid and collectible insurance. Nothing contained in these provisions relating to insurance coverage and amounts required herein shall operate as a limitation to the Exhibitor's liability.

Tucson Pride reserves the right to accept any application and to limit vendor types to assist in making this event lucrative for all vendors. Tucson Pride also reserves the right to remove a vendor the day of the event if vendor representatives are disrespectful, disruptive or fail to comply with guidelines.

I hereby agree to honor and abide by all rules, regulations, terms and procedures as outlined in the 2016 Exhibitor Guidelines, and to uphold the purpose of "Pride in the Desert" 2016 ,

Saturday, October 1, 2016. I understand that it is my responsibility to communicate all information contained within the guidelines to those acting on my behalf, to insure compliance.
