Members Report

Just about everything you read right now that has to do with fishing is about these big Bluefin tunas that have been around all season. This article is no different. After sitting in traffic for 4 ½ hours I finally made it down to fisherman's landing and amazingly was able to find a parking spot daily quickly. Around 830pm we loaded up the boat and I heard up to talk to Pat and see what our options were. After a brief chat we decided to head up to the 43 and San Clemente island for some big Bluefin.

Morning came quickly and almost immediately we were on fish. Fish boiling all over. Huge fish! 200+lb fish! Seeing all this I decided to grab my 60lb setup and a flat fall jig and preceded to get a sore arm with nothing to show for it. Bait after bait was fly lined and the boat sat fishless. This continued until about noon when we pulled up on a high spot and dropped anchor. I quickly grabbed my 9' lead head rod with an avet sx and 25lb line with a #2 hook. After tossing a sardine out I started second guessing the tackle that I was using. Too late! I finally got bit and immediately knew it wasn't a small fish. It went straight out and almost spooled me. I know, it's 25# line so almost getting spooled doesn't mean much, except that this happened two more times. Finally, I got him straight up and down and proceeded to watch my spectra/floro splice go out and come back on the reel about 700 times. After 90 minutes I finally got the fish to gaff and Mikey proceeded to stick and pull a nice 50lb Bluefin over the rail.

Although there is a huge amount of fish at the island right now they just don't want to bite. We finished our trip with 30 fish ranging from 25lbs 95lbs and all Caught or 23/30lb except the three 85-95lb fish which were all kite fish and caught on 140lb mono.
