The Nominating Committee of the Woodwind Lakes HOA Board is excited to announce we are actively seeking candidates to run in the October 15th election at our Annual Homeowners Meeting. There are three open Board seats this year. This is a fantastic opportunity for interested individuals to contribute to the governance and direction of our community.

The elected individuals will play a vital role in communicating with Association members, ensuring a transparent vision for the community image and culture, while also safeguarding and preserving the Association's assets. Moreover, they will help minimize financial risks and maintain the community's property values.

We are looking for individuals who are willing to:

- 1. Function as a liaison to the general membership, facilitating communication and serving as an interface with the community manager to expedite work requests.
- Work closely with existing Board members to address the association's priorities effectively.
