1. The meeting was called to order by Mayor Comerford at 7:07 p.m.

He also commended his staff for all of their hard work. Vice-Mayor Block presented the Chief with a T-shirt. Town Administer Kevin Lucas said he echoed the Chief's comments on commending staff and residents.

LANDSCAPING AND LANDSCAPE PLANS; ARTIFICIAL TURF TO AMEND SUBSECTION (B)(3) IN ORDER TO REDUCE THE REQUIRED BUFFER FOR ARTIFICIAL TURF IN REAR AND SIDE YARD AREAS FROM FIVE (5') FEET TO TWO AND ONE HALF (2.5') FEET; PROVIDING AUTHORITY TO CODIFY, PROVIDING A CONFLICTS CLAUSE, A SEVERABILITY CLAUSE AND AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

6. Vote: First Reading: Ordinance: 04-2019

AN ORDINANCE OF THE TOWN COMMISSION OF THE TOWN OF JUPITER INLET COLONY, FLORIDA AMENDING CHAPTER 4 BUILDING AND BUILDING REGULATIONS, ARTICLE I. IN GENERAL, SECTION 4-2 TERM OF BUILDING PERMITS: FILL, REMOVAL OR REGRADING PLANS; SITE PLAN; MAXIMUM HEIGHT CERTIFICATION REQUIRED OF THE CODE OF ORDINANCES TO PROVIDE THAT THE TERM OF A BUILDING PERMIT FOR THE CONSTRUCTION OF A NEW RESIDENCE WITH 4000 SQUARE FEET OR LESS UNDER AIR SHALL BE TWELVE (12) MONTHS AND THE TERM OF A BUILDING PERMIT FOR THE CONSTRUCTION OF A NEW RESIDENCE WITH GREATER THAN 4000 SQUARE FEET UNDER AIR SHALL BE EIGHTEEN (18) MONTHS: PROVIDING FOR THE TERM OF RENEWAL PERMITS AND PROVIDING FOR A FULL RE-SUBMITTAL OF BUILDING PLANS IN THE EVENT A THIRD RENEWAL PERMIT IS NECESSARY; PROVIDING FOR THE SUBMITTAL OF A CONSTRUCTION SCHEDULE FOR NEW CONSTRUCTION AND MAJOR REMODEL PROJECTS; PROVIDING AUTHORITY TO CODIFY; PROVIDING A CONFLICTS CLAUSE, A SEVERABILITY CLAUSE AND AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

Discussion: Dr. Bill Whiteford gave a brief explanation of the Ordinance. Building and Zoning Chairman Earl Fischer commented on the Committee's decision to support the Ordinance. The Committee feels this Ordinance will improve the construction sites and encourage contractors to get the jobs done in a reasonable amount of time. Lisa Hines, Building and Zoning Member also commented on the Ordinance.

7. Resolution 2019-07
