Who We Are



The *Foundation for Catholic Education* is an independent non-profit organization that provides scholarship opportunities to Pennsylvania's low income families. We partner families and schools with businesses and philanthropic leaders to provide scholarships that allow children to attend the school that best meets their educational needs. Since 2011, the Foundation has provided **1.75 million** to over 925 students.



How PA Educational Tax Credits Work



Through the PA Educational Improvement Tax Credit (EITC) and the PA Opportunity Scholarship Tax Credit (OSTC), a business can redirect its tax liability by donating to an eligible scholarship organization, like the **Foundation for Catholic Education**. In turn, the **Foundation for Catholic Education** provides low-income **Montgomery County** children with scholarships to attend quality, K-8th grade Catholic schools of their choice. The EITC/OSTC program offers donors a PA tax credit for 75% for a one-year commitment and a 90% tax credit for a two-year commitment.



How Can You Help Your Local Community



Today, there are millions of EITC/OSTC dollars available for businesses. Your contribution can make a large impact on a community. More than just educational institutions, Catholic schools promote the development of social capital—the social networks and mutual trust that form the foundation of safe and cohesive communities. Studies show that Catholic school kids do better than their public school counterparts in reading, writing and math, and score higher on SATs. These same students will soon be joining the work force.
