Tannenbaum Forest Donates to a Childrens Hospital and Five Charities

Amana Colonies Festivals is pleased to report that a donation of \$5,000 has been given to the University of Iowa Stead Family Childrens Hospital as a result of the 2025 Tannenbaum Forest.

In addition to the donation to the U of Iowa Stead Family Childrens Hospital, donations of \$200 were made to KCRG Coats for Kids; The Clear Creek Amana School Foundation; Iowa County Compass "Hope for All" cancer support foundation; Iowa County Safe Haven; and the Amana Community Public Library.

About 12,000 visitors came through the forest in 2025, reported Chelsea Blake, the new Amana Colonies Festivals director. Blake coordinated the Tannenbaum Forest and is at work right now on 2026 events in the Colonies.

Despite a blizzard Thanksgiving Saturday which closed the forest all day about 1,000 people visited the forest the first weekend it was open. The second weekend, Dec. 5 - 7, some 3,000 people visited the forest. A deep freeze on Saturday Dec. 12 - 13, the third weekend, kept numbers down, but still about 2,000 came through the doors.

The final weekend when warmer weather and a rush to see the forest before closing brought 6,000 visitors to the forest.

Overall attendance was down compared to previous years. In 2023, exactly 18,528 people visited the forest while in 2023 there were 16,247 people through the forest.

Amana Colony volunteers, when asked, wondered if perhaps having the forest open Wednesday afternoon and Thursday afternoon might allow more people to come see the forest and potentially offsetting a snowy weekend. Certainly having the forest open additional evening hours this year was a good thing.

All agree that signing up volunteers to work the forest is key and this past year there were times when that was difficult. So make a note to sign up to support the Tannenbaum 2026 if you wish to help this effort.

scholarship application process, offering students the opportunity to receive a share of over \$700,000 in scholarships. The deadline to apply is 8 p.m. on March 11.

The CFNEIA scholarship program supports high school, college, and adult students in pursuing higher education. In 2025, CFNEIA awarded 243 scholarships, averaging over \$3,000 per recipient. Scholarship notifications for 2025 will be sent in June, with selections finalized in May.

Students interested in applying should visit www.cfneia.org/scholarships to view the eligibility checklist and access the application. The common application requires, your name, address and basic information, academic record or transcript, summary of activities, an essay and letter of recommendation. Some scholarships may require additional materials, which will be outlined in the application. All required materials must be submitted through CFNEIA's online system by the March 11 deadline. CFNEIA scholarships are based on factors such as financial need, academic performance, field of study, and community involvement.

a. 2026-002 Hotel Millwright /800 48th Ave./ HP-I/ Replace (2) 48 3/8" X 73 1/2" wooden windows with vinyl replacements in room 141. Replace (3) 41 1/2" X 74 1/2" wooden windows with vinyl replacements in room 127 & 129.
b. 2025-074 Amana Society Inc. (Homestead cattle barn) /parcel 080303041/ HP-A/ Switch from approved corrugated galvanized steel to Pro rib for the entire roof.
c. 2025-004 Amana Society Inc. /Parcel 1536-0303-3 (South Amana)/ HP-C/ Replace 2 28x45 wooden 6/6 windows with 28x45 vinyl. Install 4 new 28x45 6/6 vinyl windows. Install 10x8 steel, white, no windows, overhead garage door on S side. Close off existing service door on S side and install new steel, white 36X80 walk in door on S side next to the overhead door. Remove/frame in all sliding doors on S side. Install ½ round seamless galvanized gutters and galvanized downspouts on S & N side. Install white smart side facia and soffit on N & S side. Install white vertical board and batten siding on entire structure. Replace current steel roof with new pro rib steel roofing. Install 5 galvanized gooseneck lights on S side. Rebuild lean-to on N side, size will not change and will match the rest of the building.
d. 2026-005 Amana Heritage Society (Cooper shop) /2511 J St. Middle Amana/HP-C/ Tear off existing siding and trellis, replace with cedar siding & trellis. Install 3 board fence with cedar toned post and cedar boards east/west perpendicular to the street. Reglaze and repair salvageable wooden windows. Unsalvageable windows will be replaced with matching windows from the east attic barn. Remove and replace the existing east-facing foundation pier.
