Answer from Sue Baker - "zero" (and no claim has ever been filed)

Presentation Overview:

No changes to mapping of flood zone – same as 1980's map

10-20' contour lines, with existing topography limitations

What is changing?

Zone identifications -

AE (100 year flood plain) – need zoning for this area

Z - 500 year flood plain - no need for zoning

C - outside flood area

Data - Changed way the "Zero Foot" mark is designated

Panels - positional changes, but nothing substantive

Coastal areas have changes, but no new data for Baldwin.

Timeline – unofficially, it seems like the process is going little slower than expected because appeal from Plymouth, MA

(review panel working to look at underlying methodology)

Impact – final maps not adopted, so we won't be ready by 3/15 town meeting.

Sue says she will let us know when the maps go final....when that happens then they will provide a model ordinance, panels specific for Baldwin, and make it easy for us.

One thing we need to review the hard copy to check the names or roads, water bodies, etc. – the Planning Board will undertake that review. Send comments to Brian Caufield (contact information is on the sheet that was handed out).

Second Item -

Maietta – general discussion of agreement to pay back taxes and impact on conditional use permit.

CarlBurnell Sub Division – we are going to invite sub-divider withdraw plan for quickest resolution.
