MAIL or DROP OFF - To be acceptable, submit entry, with the required entry fee, on an official AKC entry form, or copy, including the agreement and instructions. Please type or neatly print.

A recording fee of 50 cents per first entry of each dog and Event Service Fee of \$3.00 per entry is required for each dog entered at any Licensed or Member Club Show or Obedience Trial. This recording fee is to be collected by the show giving club and paid to the American Kennel Club. If a dog is entered in more than one class at the show, the recording fee is to be collected on the first entry only Ch. 11, Section 2, AKC Dog Show Rules. (This is already included in the entry fee.)

- -The club assumes no responsibility for a wrong entry.
- -Entries without fees cannot be accepted. Entries specifying any condition as to acceptance cannot be accepted. Unsigned, incomplete, telephone, fax or email entries will not be accepted.
- -The owner is responsible for errors on entry forms, for entering the same dog twice, or for entering a dog in a class in which it is ineligible to compete, regardless of who makes such errors. No dog wrongly entered in a class may be transferred to another class after close of entries. Changes, additions, or corrections to entry forms must be received in writing prior to close of entries. Changes by telephone are not acceptable.
- -Entries will receive an email confirmation within 7 days after receipt, if an email address is provided on the entry form, otherwise, the confirmation will be sent via USPS standard mail. If acknowledgments are not received by an exhibitor 7 days prior to the Trial, please notify the Trial Secretary.

- 2. NO smoking allowed on the grounds.

- **4.** When entering the building you will enter and exit through the side door.
- Crating: Outdoors on grass. NO Stakes allowed. Wire/metal crates are encouraged for safety and ventilation. Mesh crate must be completely zipped closed while dog is inside
- 6. Dogs that escape from crate or are uncontrolled must be removed from the show site.
- Please keep dogs quiet, if barking cannot be controlled you will be asked to leave. Keep dogs on leash while not exhibiting.
- **8.** EXHIBITORS RESPONSIBLE FOR CLEANING UP AFTER THEIR DOGS.
